Lot 1 and Lot 2 of Kosma Subdivision, being a subdivision of part of Tract 23, McNally Third Subdivision, Sheridan County, Wyoming

TOGETHER with all improvements situate thereon, and all appurtenances and hereditaments appertaining thereto.

SUBJECT to all reservations, restrictions, easements, rights-of-way and covenants of record.

Hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State of Wyoming.

This Warranty Deed is given in order to make certain that all of the Grantors' right, title, and interest in the above described lands, which were acquired in two separate instruments, have merged. To avoid all doubt, the exclusive right afforded to the owner of Lot 1 to that certain water well under permit from the State of Wyoming, Permit No. U.W. 32366 which is located on Lot 2 and the 20-foot wide easement associated therewith, each of which are created by that certain *Warranty Deed* from Joseph William Kosma and Veronica J.
