

In consideration of the sum of Ten Dollars and other consideration, CLIFFORD G. HAYNES and ELIZABETH ANNE HAYNES, husband and wife, of Sheridan County, Wyoming, "GRANTORS", hereby convey and transfer unto NORMATIVE SERVICES, INC., a Wyoming non-profit corporation, "GRANTEE" the following right-of-way for a road across the land of Grantors in favor of Grantee and in favor of Grantees lands located in Lot "I" of the M. Guy Wood Ranch Subdivision lying South of the center of Big Goose Creek.

Grantors grant and convey to Grantee a sixty-foot road right-of-way located in Lot A of the Perkins Ranch Subdivision, being a subdivision located in the $W\frac{1}{2}SE\frac{1}{4}SE\frac{1}{4}$, Section 31, Township 56 North, Range 84 West and in the $W\frac{1}{2}$ of Lot 1, Section 6, Township 55 North, Range 84 West, Sixth Principal Meridian, Sheridan County, Wyoming having the following centerline:

BEGINNING at a point which is located North $01^{\circ}02'$ West 1,264.5 feet; Thence North $88^{\circ}52'$ East 30.0 feet from the original Southwest corner of Lot A; Thence South $01^{\circ}02'$ East 1,161.8 feet to the PC of a curve to the left with a radius of 100.0 feet, a chord of South $34^{\circ}13'$ East 109.4 feet to the PT of said curve; Thence South $67^{\circ}25'$ East 248.7 feet to the PC of a curve to the left with a radius of 100.0 feet, a chord of South $85^{\circ}32'$ East 62.2 feet to the PT of said curve; Thence North $76^{\circ}20'$ East 215.9 feet to a point on the East line of Lot A.

This right-of-way is to be an easement over the land of Grantors for the use and benefit of Grantee and the above described lands of Grantee for all private and public purposes associated with the operation of Grantee's non-profit enterprises.

This right-of-way is expressly limited for a period of five years from the date hereof or the sooner termination of charitable business activities upon the lands benefitted hereunder by Grantee for any reason, and shall not be further conveyed or transferred by assignment or otherwise without Grantors' express approval.

Grantee shall maintain the right-of-way at its own expense and indemnify and hold Grantors harmless from any and all claims, demands and judgments associated with the use of the same.
