Griffith, Nancy Burns Brooks, Dorothy McMurray Burns and Ruth Burns Hutton of the County of Sheridan and State of Wyoming, hereinafter called the grantor, hereby grants to the State of Wyoming, hereinafter called the granter the right to lay out, construct, inspect, operate and maintain a road for the use of the public over and across the following described land located in the County of Sheridan State of Wyoming, to-wit: A fifty acre tract of land situate in the SE1SW1 and SW1SE1 of Section 23 and the NWINE; and NEINW; of Section 26, T. 56 N., R. The report of the property of scribed as follows: \*Beginning at a point on the South line of the NE4NW4 of said Section 26, 1012.8 feet east of the Southwest corner of said NE NW thence North a distance of 1517 feet to the South line of Fifth Avenue of the West View Addition to the City of Sheridan, Wyoming; thence S. 77°15' E. along the South line of said Fifth Avenue and the South line of the County Road a distance of 1220 feet; thence N. 76°53' E. along the South line of the County Road a distance of 431 feet to a point on the East line of the NW1NE1 of said Section 26; thence South along said East line a distance of 1318 feet to the Southeast corner of said NW1/4NE1; thence West a distance of 1627.2 feet, more or less, to the point of beginning."

The highway right of way being more particularly described as follows:
