THE COURT, having considered the Petition for Distribution of Real Property filed by Darlene M. Meece, pursuant to Wyoming Statute Section 2-1-205 and being fully advised in the premises, finds as follows:

1. Martin Lee Meece died on January 29, 2016 and was possessed of fee simple interest in the following described real property located in Sheridan County, Wyoming:

Lots 4 and 5, in Block 42, Downer Addition to the Town, now City of Sheridan, Sheridan County, Wyoming AND the West one-half of that portion of the vacated alley adjacent to said Lots 4 and 5.

- 4. More than thirty days have elapsed since Martin Lee Meece's death and no application for the appointment of a personal representative is pending in his estate, nor has such an application been granted in any jurisdiction.
- 5. Petitioner, the claiming distributee, is the surviving spouse of the decedent and is entitled to the property by virtue of the intestacy laws of the State of Wyoming, on behalf of herself and the decedent's five (5) children for whom Darlene M. Meece is the agent and/or legal custodian, (one half for herself and one half for his children: Sabrina K. Zowada, Charlene J. Meece, Samantha J. Meece, Ashley M. Meece, and Colton W. Meece) as tenants in common.
