RESOLUTION

WHEREAS, certain portions of the previously existing right of way of U.S. Highway 87 and the Decker Secondary Highway in Sheridan County, Wyoming as previously located and traveled, are no longer needed for State highway and public use purposes.

NOW THEREFORE, BE IT RESOLVED, that acting under the provisions of Session Laws of Wyoming, 1959, Chapter 160, Section 1, the following described existing highway right of way be abandoned, to wit:

Decker Road - Project S-265 (2)

"Beginning at a point on the easterly right of way boundary of the presently existing U.S. Highway Number 87 situated in the NE 1/4 SW 1/4 of Section 22, T. 57 N., R. 84 W. of the 6th P.M., Wyoming, which point of beginning bears N. 54° 28° W. a distance of 4150.7 feet from the southeast corner of said Section 22;
