## DRAINAGE FACILITY EASEMENT

Noble, husband and wife, as tenants by the entirety with full right of survivorship**, hereinafter called the grantor, hereby grants to THE TRANSPORTATION COMMISSION OF WYOMING, 5300 Bishop Blvd., Cheyenne, Wyoming, 82009-3340, its assigns or successors, hereinafter called the grantee, the right to lay out, construct, inspect, maintain and operate drainage facilities, and the right to discharge drainage and flood waters for the benefit of the public, being over, across and upon the following described lands located in the County of Sheridan and State of Wyoming, to-wit:

## Parcel 1.

A portion of the W½SE¼ of Section 14, T.54N., R.83W. of the 6th P.M., Sheridan County, Wyoming, being more particularly described by metes and bounds as follows:

thence S.73°52'46.9"E. along said presently existing right-of-way boundary of U.S. Highway 14 a distance of 15 meters (49.21 feet), more or less, to the point of beginning.

Grantor will not use or permit to be used said land for any purpose which will inhibit use by the grantee for construction, operation and maintenance of said drainage facilities.
