WITNESSETH, that for valuable considerations received, OWNER does hereby grant, bargain, sell and convey unto COMPANY, its successors and assigns, an easement __15____ feet in width, being __7.5___ feet left, and __7.5___ feet right of the center line as laid out and/or surveyed, or as finally installed on the hereinafter described lands, together with the right to construct, operate, maintain, repair, remove and replace a gas pipeline or lines, including necessary pipes, poles, and fixtures, and a buried or semiburied electric distribution system, street lighting system, or any combination thereof including the necessary cables, podestals, transformers, transformer bases and other fixtures and apparatus in connection therewith through, over under, and across the following described real estate, situated in the County of Sheridan , State of Wyoming , namely: A tract of land wituated in Lot 6 of Section 6. Township 54 Worth, Range 87 West and in the SE 1/45E 1/4 of Section 1, Pownship54 North, Range 85 West of theSixth Principal Meridian, all in Sheridan County, Myoming; sore particularly described as follows: Being a strip of land 15 feet in width, lying 7.5 feet on each side of a centerline described as beginning at a point which bears S.30°50'24°E. a distance of 97.94 feet from the West 1/4 Corner of said Section 6, said point of beginning being an existing power pole; thence N.66°12'45°W. for a distance of 21.97 feet; thence N.68°33'36°W. for a distance of 21.97 feet; thence N.68°25'37°W. for a distance of \$2.13 feet to a point on the Sast line of the Del Rossi property, this also being the point of terminus which bears 3.87013'56'V. a distance of 180.13 feet from the West 1/4 Corner of said Section 6. COMPANY by the acceptance hereof, hereby agrees that it will pay any and all damages that may result, including crops, fences, buildings and improvements on said premises, caused by constructing, maintaining, repairing, operating, replacing or removing said underground lines. The damages, if not mutually agreed upon, may be determined by three disinterested persons, one to be selected by COMPANY and one by OWNER; these two shall select the third person. The award of these three persons shall be final and conclusive. If the herein described lands are in the State of North Dakota, this easement is limited to a term of 99 years. If the herein described lands are in the State of Wyoming, OWNER does hereby release and waive all rights under and by virtue of the homesteed exemption laws of that state.
