26. It was moved by Commissioner Pleak, seconded by Commissioner Gorman and carried unanimously that the following Resolution be adopted:

RESOLUTION

WHEREAS, certain portions of the previously existing right of way of U.S. Highway 87 and the Decker Secondary Highway in Sheridan County, Wyoming, have been reconstructed and relocated; and

WHEREAS, certain portions of said Decker Secondary Highway and U.S. Highway 87 in Sheridan County, Wyoming, as previously located and travelled are no longer needed for state highway and public use purposes; and

WHEREAS, this Commission has previously, on the 20 day of January, 1961, resolved that portions of said highways be abandoned, acting under the provisions of Session Laws of Wyoming, 1959, Chapter 160, Section 1; and

WHEREAS, a certified copy of said Resolution has been recorded by the County Clerk and Ex-officio Recorder of Deeds for Sheridan County, Wyoming in Book 129 of Deeds, Page 26, in the records for Sheridan County, Wyoming; and

WHEREAS, the description in said Resolution, as passed and recorded, was incorrect and this Commission wishes to correct the same.

NOW THEREFORE, BE IT RESOLVED THAT acting under the provisions of the Session Laws of Wyoming, 1959, Chapter 160, Section 1, the following described existing highway right of way be abandoned, to wit:

Decker Road - Project S-265 (2)

"Beginning at a point on the easterly right of way boundary of the presently existing U.S. Highway Number 87 situated in the NE 1/4 SW 1/4 of Section 22, T. 57 N., R. 84 W. of the 6th P.M., Wyoming, which point of beginning bears N. 54° 28' W. a distance of 4150.7 feet from the southeast corner of said Section 22;

thence running in an easterly direction for a distance of approximately 0.585 miles through Sections 22 and 23, said township and range;

To a point of ending on the northwesterly right of way boundary of the presently existing relocated Decker Connection Road, Project No. S-1706, which point of ending being situated in the SW 1/4 NW 1/4 of said Section 23 and bears N. 76° 49° E. a distance of 313.2 feet, more or less, from a point on the west boundary of said Section 23 from which the west quarter corner thereof bears S. 13° 41° E. a distance of 181 feet."

U.S. Highway 87 - Project FAP 179 AR

"Beginning at a point on the centerline of existing U.S. Highway 87 situated in the NW 1/4 of Section 22, T. 57 N., R. 84 W., 6th P.M., Sheridan County, Wyoming, said point of beginning being on the West line of said Section 22, and bears S. 0° 36° W. a distance of 614 feet from the northwest corner of said Section 22;

thence running in a southerly direction along the centerline of U. S. 87 for a distance of approximately 1.02 miles through the west one-half of said Section 22 to a point of ending on the northwesterly right of way boundary of presently existing re-located Decker Road Connection, Project No. S-1706, said point of ending being approximately 73.5 feet left of engineer station 7 / 14 of said Decker Road Connection, and bears N. 42° 25' E. a distance of 1844.1 feet, more or less, from the southwest corner of Section 22, all being in the west one-half of Section 22, T. 57 N., R. 84 W., 6th P.M., Sheridan County, Wyoming, as more particularly shown on the attached map, dated Ferruary 17, 1961 marked Exhibit "A", and by this reference made a part hereof."
