## **MEMORANDUM OF SURFACE USE AGREEMENT**

## KNOW ALL MEN BY THESE PRESENTS:

Corlies Clayburgh and Marie Clayburgh, husband and wife, of P.O. Box 177, Sheridan, WY 82801 (collectively, the "Owner"), and J. M. Huber Corporation, a New Jersey corporation, with offices located at 1050 17th Street, Suite 800, Denver, CO 80265 ("Huber"). have entered into that certain Surface Use Agreement dated January 12th, 2009 (the "Agreement") covering the following real property located in Sheridan County, Wyoming:

The parties acknowledge they are bound by all the terms and conditions of the Agreement and that the Agreement binds and inures to the benefit of Owner and Huber and their respective heirs, personal representatives, successors and assigns.


