## PARTIAL VACATION OF PLAT AND RE-PLAT

WHEREAS, Broadway Properties, LLC, a Wyoming limited liability company, is the owner of Parcel II more particularly described as follows:

Lot 15 of Sheridan Commercial Park, a subdivision in Sheridan County, Wyoming as recorded March 6, 2012 in Drawer S, Plat #140;

WHEREAS, Dan Davidson and Melaine Davidson and Broadway Properties, LLC, are referred to hereinafter as the "Owners" and the above-described Parcel I and Parcel II hereinafter as the "Lots";

WHEREAS, Owners desire to vacate said Lots as being a portion of that subdivision known and shown on the Plat of Sheridan Commercial Park, to the City of Sheridan, and desire that the subdivision, be partially vacated as to said Lots, and the Lots be re-platted in accord with the fully executed plat filed contemporaneously herewith at the office of the Sheridan County Clerk for the purpose of re-platting said Lots as the "<u>Tonka Subdivision</u>", which said plat is incorporated herein by reference;

WHEREAS, there are no other lots, tracts or parcels that have access to a public highway through said Lots, whether by easement for right of way or otherwise which would be adversely affected by the re-plat of said Lots;

WHEREAS, the undersigned acknowledge that any easements for existing utilities and public roads that may be within the boundaries of the vacated Lots are reserved for continued use to the extent necessary and not otherwise dealt with on the re-plat of the Lots; and

WHEREAS, partial vacation of the Sheridan Commercial Park, as to the above-described Lots would not reduce the value of other lots and tracts in the Subdivision;

THEREFORE, Owners hereby vacate those portions of Sheridan Commercial Park, more particularly described above as the Lots. The dedication of the Lots is hereby revoked and terminated in accordance with the approval and consent of the City of Sheridan, Sheridan County, Wyoming. Owners, by these presents, do make the above partial vacations for it and for its successors and assigns, and for all future owners of said Lots, as the same shall be replatted as the Tonka Subdivision.
