date of this Judgment at the contractual rate of 10% per annum.

2. Plaintiff is awarded judgment against Defendants Firdose Sharif Khan, Rajab

Khan, and Zarina Khan jointly and severally in the amount of \$16,307.23 plus interest accruing

after the date of this Judgment at the contractual rate of 10% per annum.

3. Plaintiff is awarded judgment against Defendants Sartaj Raja Khan, Rajab Khan,

and Zarina Khan jointly and severally in the amount of \$32,994.73 plus interest accruing after the

date of this Judgment at the contractual rate of 10% per annum.

IT IS FURTHER ORDERED by the Court that, upon further notice and hearing,

Plaintiff may apply to this Court for an amendment of this Judgment to reflect any additional

attorney's fees and costs incurred by the Plaintiff from and after the entry of this Judgment
