sum of Fifty Dollars (\$50.) in hand paid, the receipt
whereof is hereby confessed and acknowledged, do hereby

grant, bargain, sell and convey unto the United States the following real estate in the
County of Sheridan, State of Wyoming, to wit: The right to lay and construct and maintain to,
over and across the lands hereinafter described, a pipe line for the purpose of conducting
water for Fort Mackenzie, Wyoming; said pipe line to be covered to a depth of five (5) feet;
and also the perpetual right-of-way- to the extent of a strip of land ten (10) feet in width,
to, over and across the said land, in conformity with the survey and plat, and according to
the line of said pipe, being five (5) feet on each side of said pipe line as the same shall
be hereafter constructed, laid and maintained, to, over and across said land; and containing
