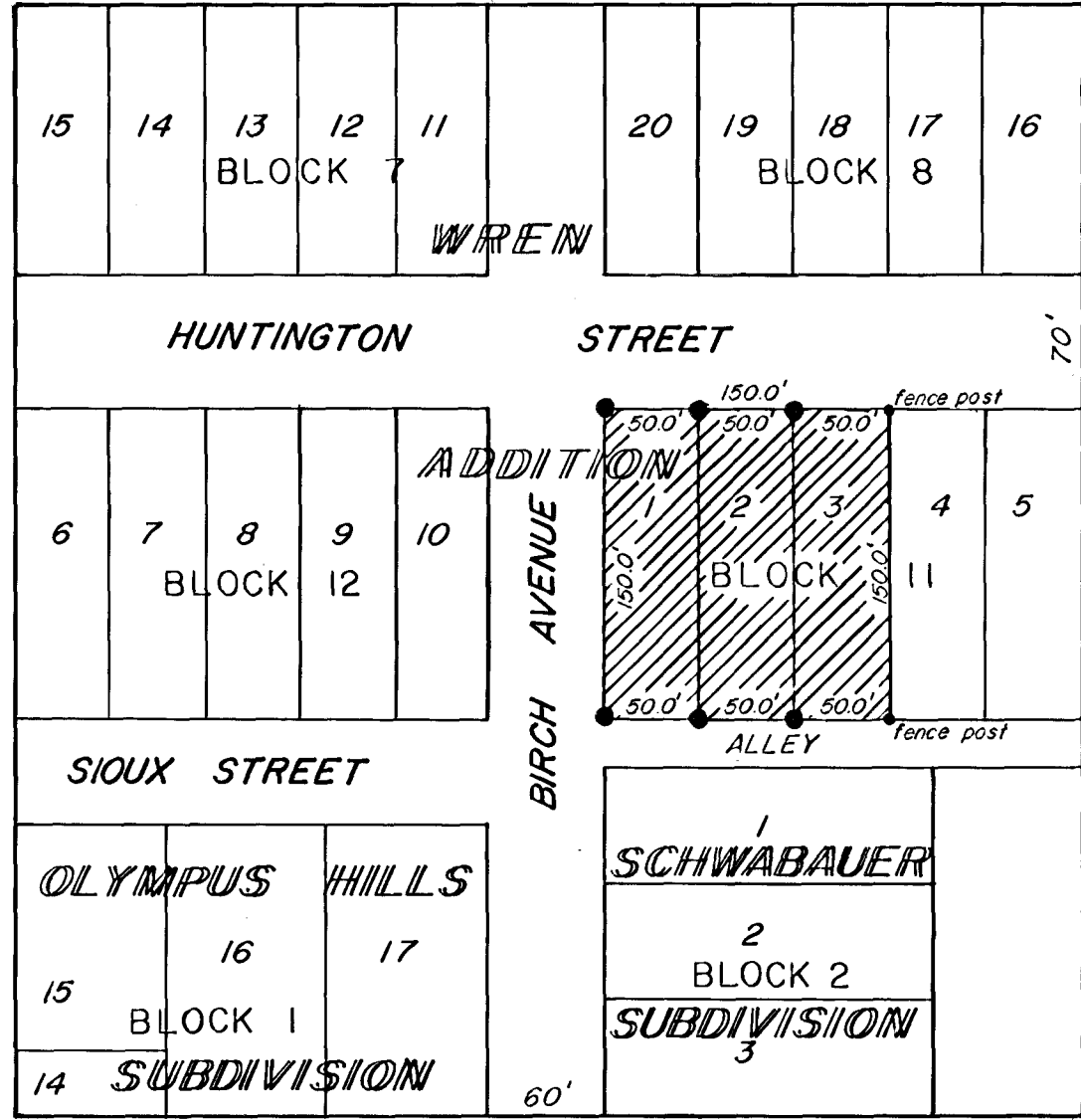
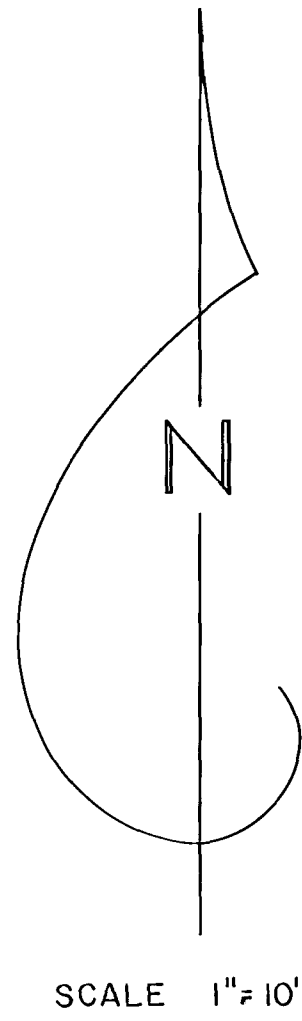
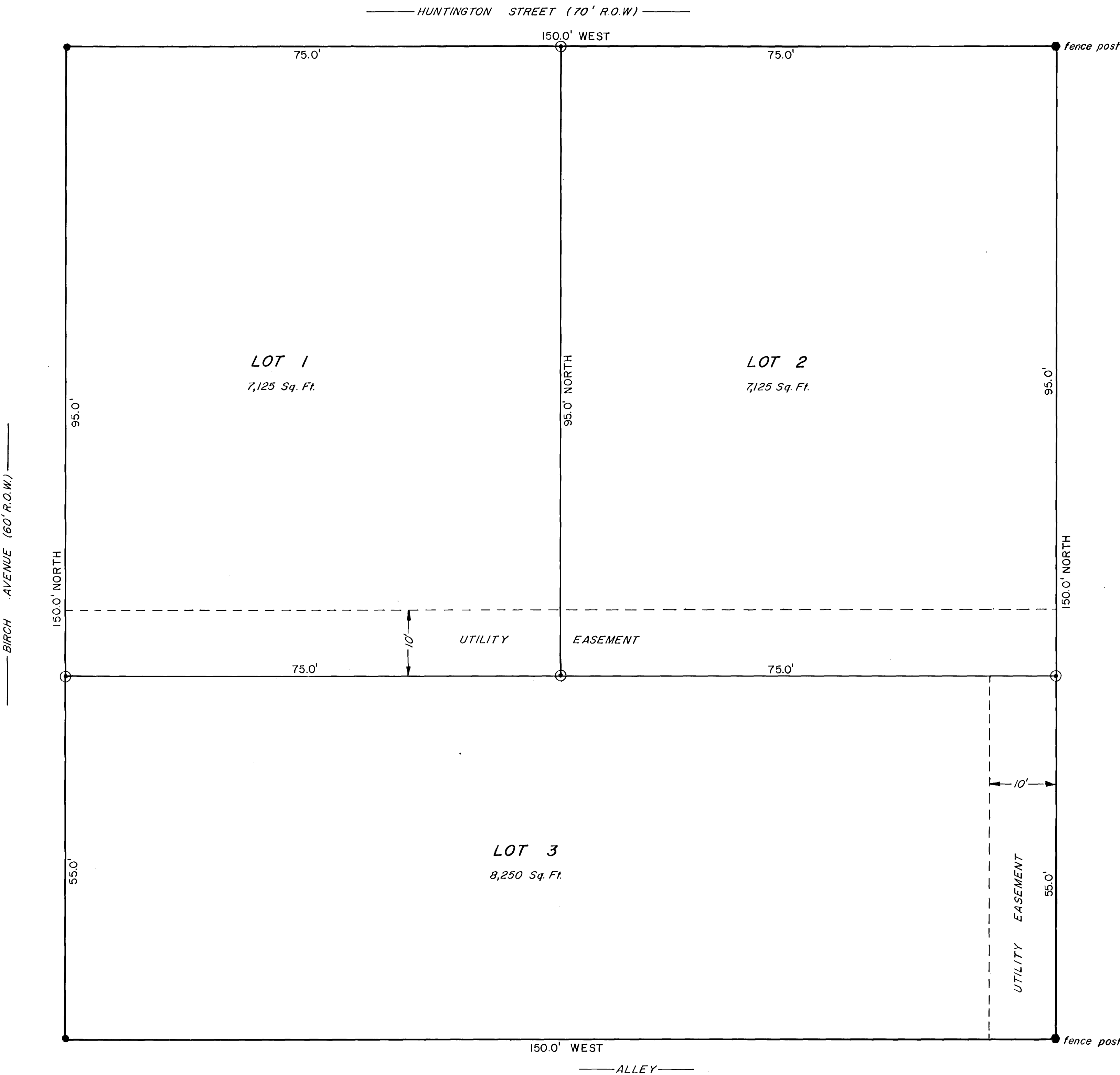


HUNTINGTON-BIRCH ADDITION
