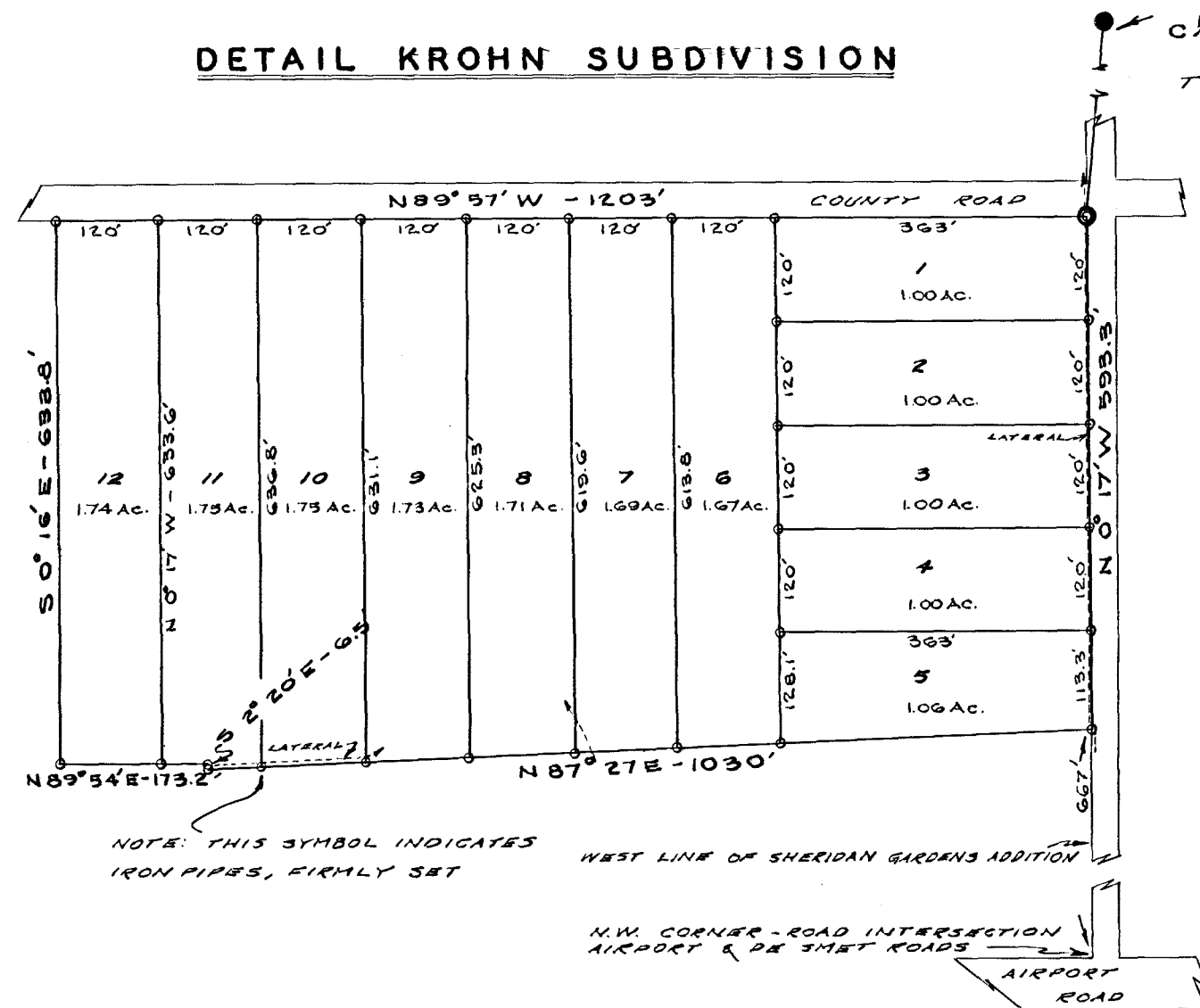


DETAIL KROHN SUBDIVISION
