(Selection List No. 12, Buffalo 06557)-said selection being made to supply the deficiency
in school sections to which the State townships were entitled.

2nd. That the State Board of Land Commissioners issued the following leases upon said land:-

- A. Lease No. 2576 to Dan Gallagher for a term of 5 years from April 10, 1899.
- B. Lease No. 6616 to Dan R. Gallagher for a term of 5 years from April 10, 1904. An assignment of this lease dated April 5, 1905 was made by Dan R. Gallagher to B. K. West and recorded April 13, 1905.
- Lease No. 12582 to B. K. West for a term of 5 years from April 10, 1909.
 This lease was later canceled on the records of this office.
- 3rd. That the Board of Land Commissioners later filed a relinquishment covering
