Peter Kiswit Sons' Co. Peter Kiswit & Sons, Inc.

Beginning at the NE corner of Section 24, T57N, R84W, Sheridan County, Wyoming; thence bearing approximately South 86°-00' West along the northern boundary of said section for an approximate distance of 3,200' to a point; thence bearing approximately North 18°-50' East for an approximate distance of 75' to a point on Sheridan-Johnson REA's existing 1-phase power line where the subject line taps and routes on *Puter Keiwit & Sons, Inc. lands (True Point Of Beginning). *Peter Kiewit Sons' Co.

The new tap line continues bearing approximately South 18°-50' West for an approximate distance of 4,072' to a point; thence bearing approximately South 07°-15' West for an approximate distance of 655' to a point; thence bearing approximately South 47°-00' East for an approximate distance of 3,150' to a point where the new 1-phase power line exits the NWNE of Section 25 and *Poter-Kiewit-& Son; -Inc. lands in mid-span (POINT OF EGRESS), this point being approximately 1050' West of the NE 1/16 corner of Section 25, T57N, R84W, Sheridan County, Wyoming. *Peter Kiewit Sons' Co.
