

LICENSE AGREEMENT

AGREEMENT MADE this day by and between, Robert D. and Barbara C. Blevins, of Sheridan, Wyoming, (hereinafter referred to as "Licensors"), being the legal owner(s) of a part of Lot 1 and all of Lots 2 & 5, Welton Subdivision, a subdivision in Sheridan County, Wyoming, as recorded in Plat Drawer W in the office of the County Clerk for Sheridan County, (hereinafter referred to as "Subdivision"), and the Sheridan Area Water Supply Joint Powers Board, a joint powers board existing by and pursuant to the laws of the State of Wyoming, a body politic and body corporate, of Sheridan County, Wyoming (hereinafter referred to as "Licensee"):

WHEREAS:

1.

All of the lot owners of said Subdivision have an easement appurtenant for the use of the roads of said Subdivision, as platted and dedicated by that certain plat of said Subdivision.

2.

In order for Licensee to deliver potable domestic water to those requesting service, Licensee must install, construct, maintain, repair and replace a water pipeline and appurtenant facilities within, along, and under Welton Lane, a road located within said Subdivision.

WHEREFORE, PREMISES CONSIDERED, Licensor grants to Licensee the right, permission and authority to construct, install, maintain, repair and replace a water pipeline and necessary facilities above or below ground surface within, along, on or below Welton Lane.


Further, Licensee agrees that:


1. Installation, construction, maintenance, repair and replacement of the water pipeline and appurtenant facilities will be accomplished in a manner that will reasonably cause the least interference with use of Welton Lane by others entitled to use of Welton Lane.

2. All disturbance of Welton Lane and its surface will be reclaimed and restored to the condition prior to disturbance at the sole cost to Licensee.


3. The water pipelines and necessary facilities shall be placed within Welton Lane.


4. Licensee is responsible for coordinating the placement of its water pipeline and appurtenant facilities with other utilities within Welton Lane as appropriate.

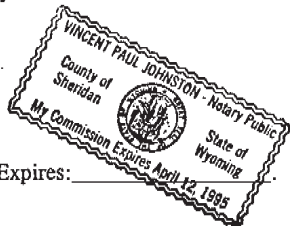
