AFFIDAVIT OF SURVIVORSHIP

Title to the real property was vested in KC Carden and Candice Carden, husband and wife, by a Quitclaim Deed from Carden, LLC, a Wyoming limited liability company, executed October 26, 2017, and recorded October 31, 2017, in Book 570, Page 163, as Document 2017-738453, of the records of Sheridan County, Wyoming.
- 5. The estate of KC Carden in the real property described above was terminated by his death. Title is now vested in Candice Carden.
