

RESTATED RATIFICATION OF COVENANTS

This *Restated Ratification of Covenants* ("Restated Ratification") is made effective the 11th day of April, 2014, by **TRUST COMPANY OF AMERICA FBO JOHN W. MUECKE** ("TCA") and **HABITAT FOR HUMANITY OF THE EASTERN BIGHORNS, INC.** ("HABITAT").

RECITALS

1. The *Amended and Restated Declaration Of Covenants, Conditions And Restrictions Of Poplar Grove Subdivision* were recorded in the land records of the Sheridan County Clerk on June 19, 2013, as Document #2013-705513, Book 541, Page 232 (the "Amended Covenants").
2. The Amended Covenants burdened and benefitted various lands described therein, including those listed on Exhibit 1 of the Amended Covenants, a portion of which have since been platted as:

Poplar Grove P.U.D. Phase Three, a subdivision to the City of Sheridan, Sheridan County, Wyoming, as recorded in the Office of the Sheridan County Clerk

("Poplar Grove Phase Three")

3. The *Ratification of Covenants* was recorded in the land records of the Sheridan County Clerk on May 14, 2014, as Document #2014-712076, Book 547, Page 18.
4. As of the date of this Restated Ratification, TCA and HABITAT own all lands located within Poplar Grove Phase Three.
5. Whereas, TCA and HABITAT desire to restate the original *Ratification of Covenants* to clarify that no modular, manufactured, or mobile home buildings shall be allowed on any lot in Poplar Grove Phase Three.

AGREEMENT

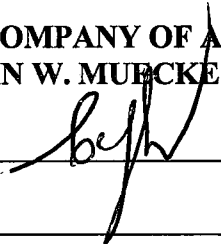
NOW, THEREFORE, TCA and HABITAT hereby declare that no modular, manufactured, or mobile home buildings shall be allowed on any lot in Poplar Grove Phase Three.

TCA and HABITAT hereby ratify the Amended Covenants as to the lands located within Poplar Grove Phase Three and declare that all lands located therein shall be held, transferred, sold, conveyed or contracted to be conveyed subject to the conditions, restrictions, reservations and covenants stated in the Amended Covenants. Each and every covenant listed in the Amended Covenants, as well as those separately stated in this Restated Ratification, (collectively "the Covenants") are for the benefit of the entire Poplar Grove Subdivision (as defined by the



Amended Covenants), including Poplar Grove Phase Three, and for the benefit of each owner of land therein. The Covenants shall run with the land and inure and pass with the Poplar Grove Subdivision and each and every parcel of land therein. The Covenants shall be binding on all owners of land within the Poplar Grove Subdivision and their successors in interest, regardless of how that interest is acquired. This includes, but is not limited to, adverse possessors, lessees and purchasers at mortgage foreclosure sales. The Covenants are imposed pursuant to a general plan for the improvement and benefit of the Poplar Grove Subdivision.

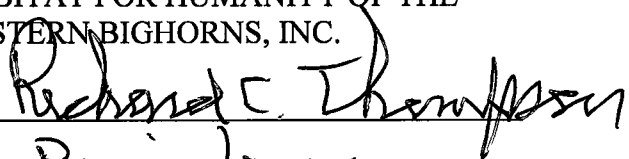

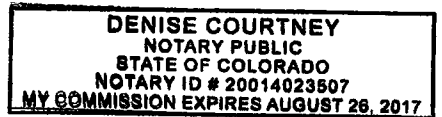
