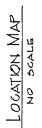
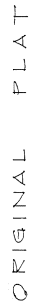


Replat of Lots 34, 35, 36 & 37, Brundage Place Addition

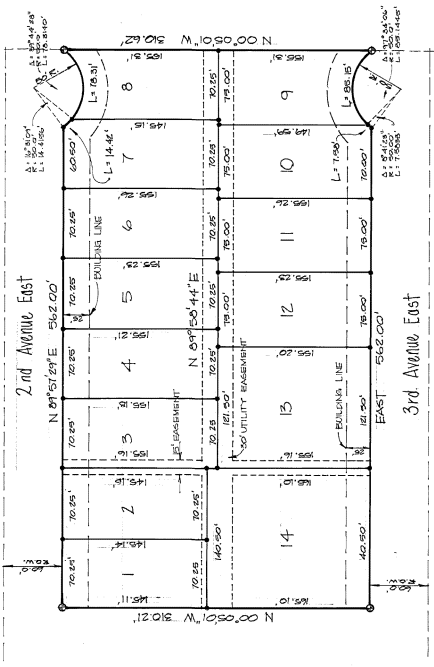

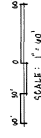


REVISED	PLAT
