 remise, release and forever quitclaim unto the said Sheridan County, Wyoming

heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as
 they may have or ought to have, in or to all the following described premises, to-wit:

The South 30 feet of the East 105 feet of the North 75 feet of Lot 1,
 and the South 30 feet of the North 75 feet of Lots 2, 3, 4 and 5, and
 also the South 15 feet of the North 45 feet of the East 30 feet of Lot
 5, in the First Addition to Kilbourne Park, being a subdivision in
 Sheridan County, Wyoming.

Said subdivision situated in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 7, Township 53 North.
 Range 83 West of the 6th P.M.

Hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the

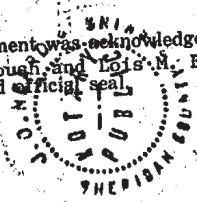
