WHEREAS, Owner desires to partially vacate said Tract 2 in Sheridan Links Planned Unit Development Subdivision, a subdivision in Sheridan County, Wyoming, filed in Drawer S, Page 143 in the Office of the Sheridan County Clerk, and desire that the said Sheridan Links Planned Unit Development Subdivision be partially vacated in accord with the re-plat filed contemporaneously herewith at the office of the Sheridan County Clerk for the sole purpose of re-platting said Tract 2 as "The Links - North Pond", which said re-plat is incorporated herein by reference;
