This Conveyance of Easement is made and entered into by EUGENE C. FTTZGERALD, as Trustee of the Eugene C. Fitzgerald Trust Dated March 12, 1991, for the Benefit of Eugene C. Fitzgerald, and Others Therein Named, HARRY W. COSNER and THERESA L. COSNER, husband and wife, and JAMES WALTON COSNER and DEBBIE A. COSNER, husband and wife, Grantors, of Sheridan County, Wyoming.

WITNESSETH

WHEREAS, Grantors are the owners of all of the lots within Wild Turkey Subdivision, a subdivision in Sheridan County, Wyoming, as recorded in Drawer W, Plat No.

WHEREAS, pursuant to the plat of Wild Turkey Subdivision, two sixty (60) foot access and utility easements are reserved across Lots 3, 4, and 7 of Wild Turkey Subdivision,

WHEREAS, the reservation of these access and utility easements is subject to the following restriction contained on the plat of Wild Turkey Subdivision:

> The access and utility easements reserved herein across lots 3, 4, and 7 are for the benefit of the land divided herein and persons acquiring ownership of property within the divided land only, and are not for the benefit of any other land or person.

WHEREAS, Grantors desire to convey said access and utility easements, and all rights and privileges incident thereto, to Grantees, for the purpose of conveying to Grantees the exclusive right to own, control, restrict and convey said access and utility easements, separate and apart from the ownership and conveyance of lots within Wild Turkey Subdivision.

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration in hand paid, the receipt and sufficiency of which is hereby acknowledged, Grantors hereby grant and convey unto EUGENE C. FITZGERALD, as Trustee of the Eugene C. Fitzgerald Trust Dated March 12, 1991, for the Benefit of Eugene C. Fitzgerald and Others Therein Named, HARRY W. COSNER and THERESA L. COSNER, husband and wife, and JAMES W. COSNER, a married man dealing in his sole and separate property, Grantees, the following:

Hereby releasing and waiving all rights under and by virtue of the homestead exemptions laws of the State of Wyoming.






