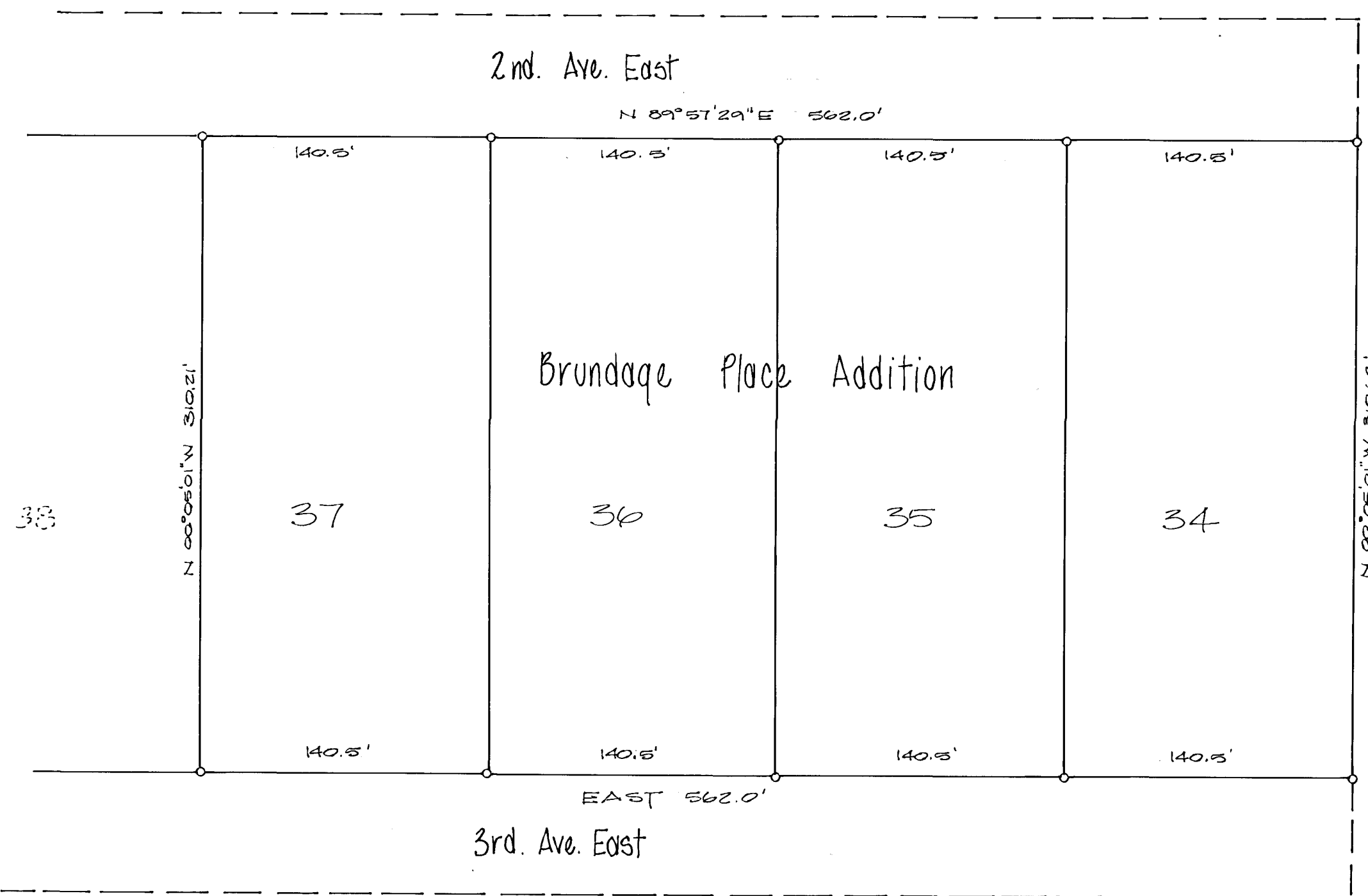
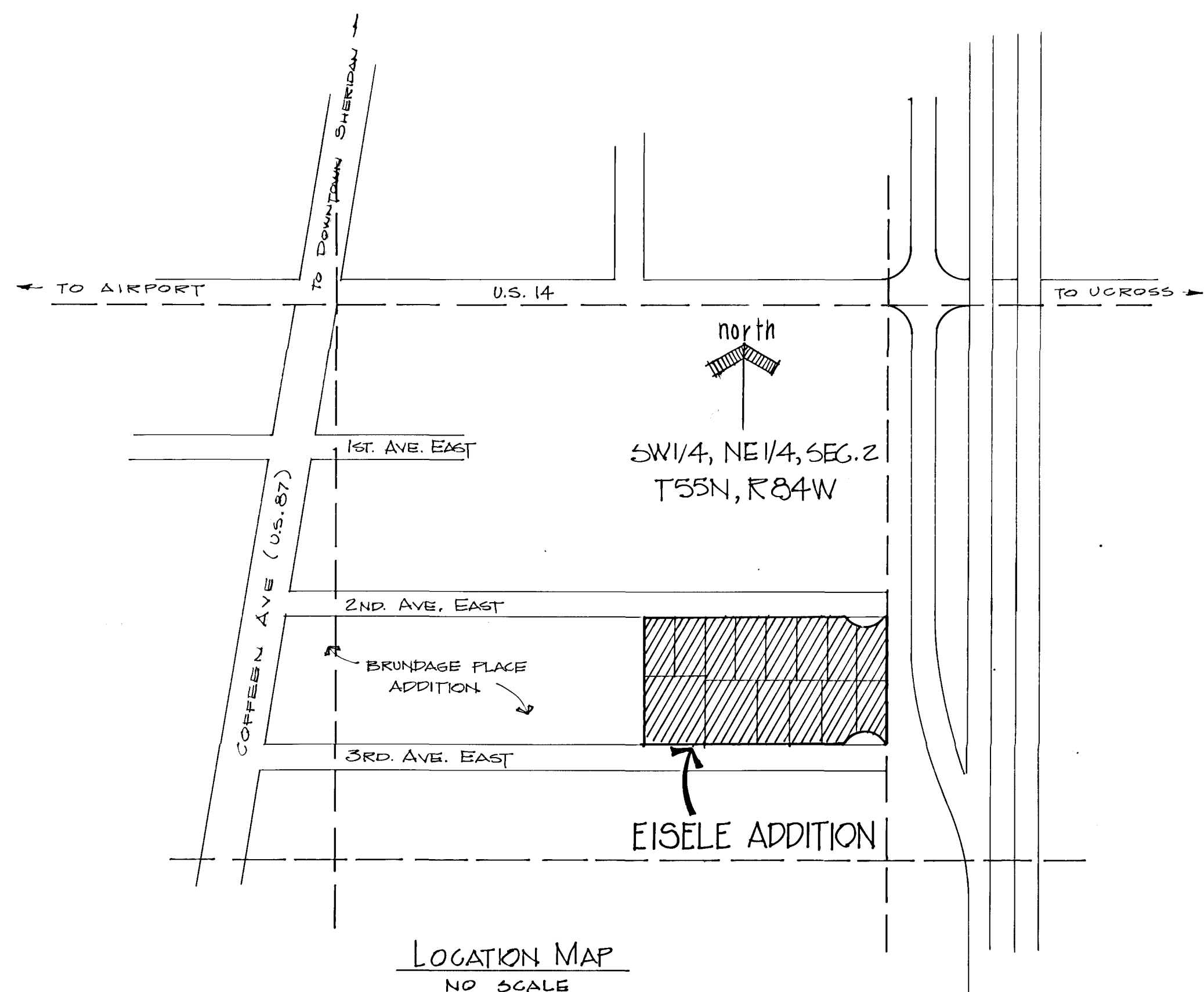


EISELE ADDITION

LEGAL DESCRIPTION

LOTS 34, 35, 36, & 37 OF THE BRUNDAGE PLACE ADDITION TO THE CITY OF SHERIDAN, WYOMING, LOCATED IN THE SW 1/4, NE 1/4, SECTION 2, T55N, R84W, 6TH P.M., SHERIDAN COUNTY, WYOMING, CONTAINING 4.005 ACRES, MORE OR LESS.

EASEMENTS

AN EASEMENT OF FIVE (5) FEET EITHER SIDE OF ALL LOT LINES AND TEN (10) FEET INSIDE ALL BOUNDARY LINES OF THE ORIGINAL LOTS OF SAID BRUNDAGE PLACE ADDITION IS TO BE PROVIDED FOR WIRES, PIPES, AND CONDUITS FOR HEATING, LIGHTING, ELECTRICITY, GAS, TELEPHONE, WATER, CATV, OR OTHER PUBLIC OR QUASI-PUBLIC UTILITY SERVICE PURPOSES, TOGETHER WITH THE RIGHT OF ENTRY AT ANY TIME FOR THE PURPOSE OF CONSTRUCTION AND REPAIR.

DEDICATION

STREETS SHOWN ON THIS PLAT AND NOT HERETOFORE DEDICATED TO PUBLIC USE ARE HEREBY SO DEDICATED.

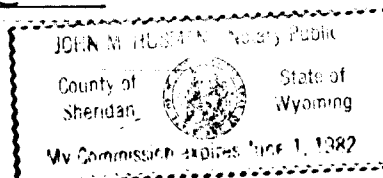

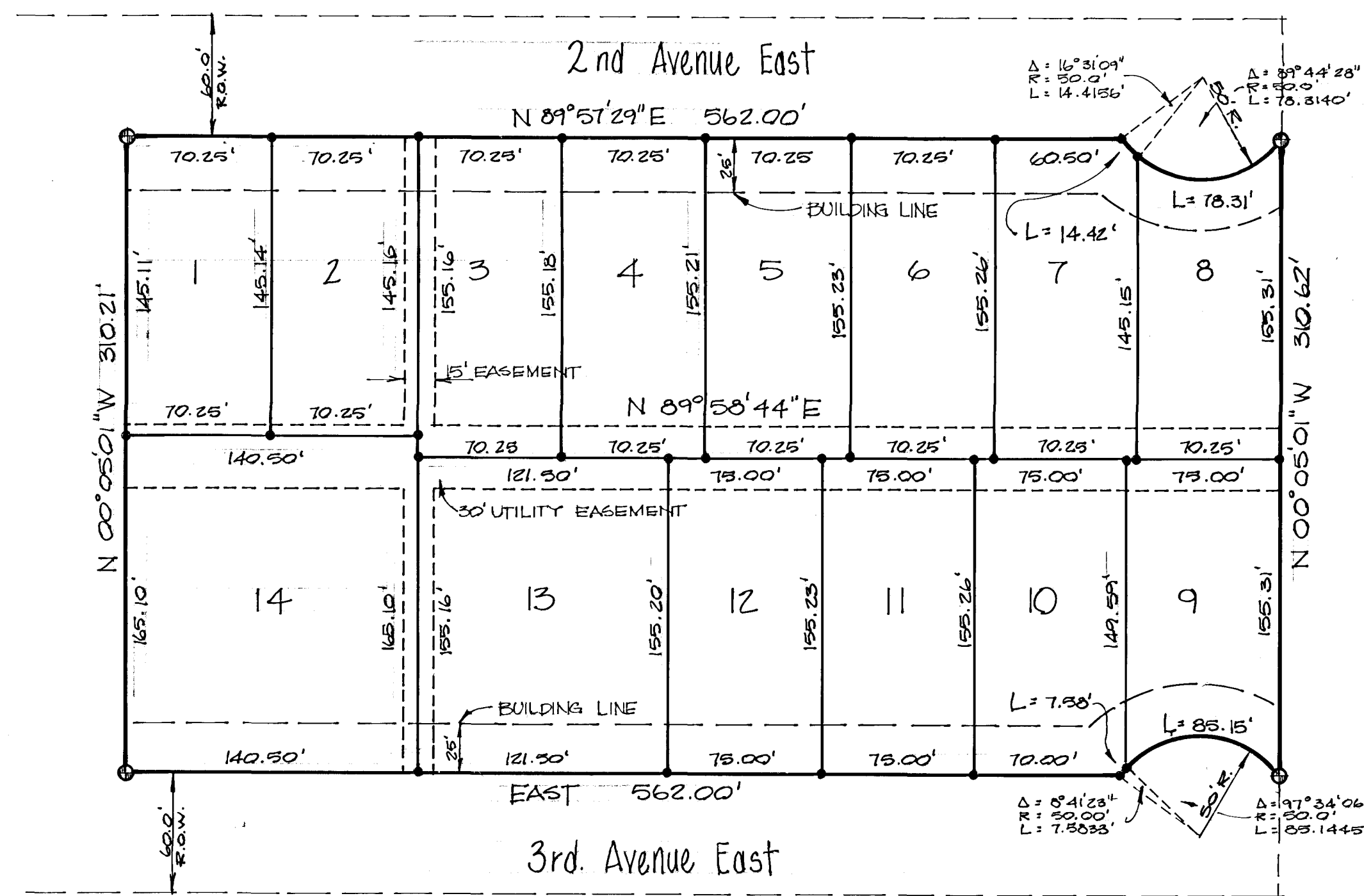

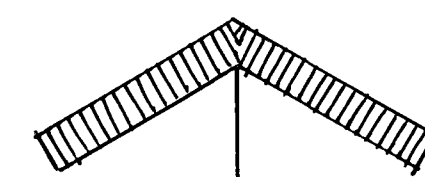
