WHEREAS, Developer, pursuant to Section 8.2 of Article VIII of the DCCRs, as the owner of more than two-thirds of the lots in the subdivision, has the right amend the DCCRs by filing this instrument of record; and

WHEREAS, at the time of this First Amendment, Developer is the owner of more than two-thirds of the lots in the subdivision and, at a meeting duly called for this purpose, the Developer did cast all of its votes in favor of this First Amendment, which votes did constitute more than two-thirds of the lots in the subdivision; and

WHEREAS, Developer, by this instrument hereby amends the existing covenants for all phases of this development as set forth herein.
