## KIEWIT SUBDIVISION AMENDED COVENANTS

## KNOW ALL MEN BY THESE PRESENTS:

The undersigned, constituting a majority of lot owners of the Kiewit Subdivision of Sheridan County, Wyoming, filed March 26, 1954 in Book 2 of Plats, Page 40, do hereby amend the covenants of said subdivision and modify the covenants set forth in deed restrictions for the lots within the subdivision, to be amended as follows:

These Covenants, are to run with the land and shall be binding on all parties and all persons claiming under them until January 1, 1961, at which time said Covenants shall be automatically extended for successive periods of 10 years unless by vote of a majority of the then owners of the lots it is agreed to change said Covenants in whole or in part.

If the parties hereto, or any of them, or their heirs or assigns, shall violate or attempt to violate any of the Covenants herein it shall be lawful for any other person or persons owning any real property situated in said development or subdivision to prosecute any proceedings at law or in equity against the person or persons violating or attempting to violate any such Covenant and either to prevent him or them from so doing or to recover damages or other dues for such violation.

Invalidation of any one of these Covenants by judgment or court order shall in no wise affect any of the other provisions which shall remain in full force and effect.

- A. All lots in the tract shall be known and described as residential lots. No structures shall be erected, altered, placed, or permitted to remain on any residential building plot other than one detached single-family dwelling, not to exceed one and one-half stories in height above the basement and the basement shall not be higher than 18" above the finished grade of said premises.
- B. No building shall be located nearer to the front line or nearer to the side street line than the building setback lines shown on the recorded plat. In any event, no buildings shall be located on any residential building plot nearer than 25 feet to the front lot line, nor nearer than 15 feet to any side street line. No building, except a detached garage or other outbuilding located 50 feet or more from the front lot line, shall be located nearer than 5 feet to any side lot line. It is understood, however, that the exception to setback lines, applying to the whole tract or to certain lots, may be made where special conditions warrant.
- C. No residential structure shall be erected or placed on any building plot, which plot has an area of less than 9,725 sq. feet or width of less than 75 feet at the front building setback line, except that a residence may be erected or placed on lots Nos. 3, 4, 5 & 6, Block 1; lots 1 and 2, Block 4; lots 1 and 2, Block 5; as shown on the recorded plat.

- D. No noxious or offensive trade or activity shall be carried on upon any lot nor shall anything be done thereon which may be or become an annoyance or nuisance to the neighborhood.
- E. Sewage Disposal. No individual sewage-disposal system shall be permitted on any lot unless such system is designed, located and constructed in accordance with the requirements, standards and recommendations of the Building Inspector of the City of Sheridan, Wyoming. Approval of such system is installed shall be obtained from such authority.
- F. No trailer, basement, tent, shack, garage, barn, or other outbuilding erected in the tract shall at any time be used as a residence temporarily or permanently, nor shall any structure of a temporary character be used as a residence.
- G. The ground floor area of the main structure, exclusive of one-story open porches and garages, shall not be less than 1,000 sq. feet.
- II. An easement is reserved over the rear 5 feet of each lot for utility installation and maintenance.
