### TEMPORARY DEED OF EASEMENT

This Temporary Deed of Easement is entered into this day of \( \bigcup\_{0V} \), 2015, by and between Charles F. Walter, Trustee of the Charles F. Walter Living Trust, dated March 9, 1999, and Barbara A. Walter, Trustee of the Barbara A Walter Living Trust, dated March 9, 1999 (hereinafter the "Grantor"), and the United States of America and its assigns (hereinafter the "Grantee"). Grantor does hereby grant and convey, for and in consideration of Two Hundred Two Dollars and Fifty Cents (\$222.75), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, unto the Grantee, its successors and assigns, a temporary easement and right of way for the installation of underground water lines for a period of twelve (12) months that will allow the Grantee to utilize the surface of the property as a staging ground for personnel, equipment, construction materials, and other items as determined by the Grantee (the "Temporary Easement"). The Temporary Easement shall extend ten (10) feet from the outer boundaries of the permanent easement area encumbered in perpetuity, as depicted and described within Exhibit A, "Survey of Easement Area," and Exhibit B, "Legal Description of Property," attached hereto and made a part hereof.

The Grantor's property, upon which the Temporary Easement is situated, is located in the County of Sheridan, State of Wyoming. The acquiring federal agency is the Department of Veteran Affairs ("VA").

The Temporary Easement is granted subject to the following conditions and provisions:

- 1. That the Grantor reserves unto itself rights for all purposes across, over, or under the Temporary Easement herein depicted or described. Such rights, however, to be exercised in a manner which will not create undue interference with the use and enjoyment by the Grantee of said Temporary Easement, and are not covenanted by the Grantor in another part of this Temporary Deed of Easement.
- 2. Grantor covenants and agrees that no building, structure or other above-ground improvement shall be erected or constructed on the Temporary Easement without VA's prior written consent, and that the present grade or ground level of the property depicted and described in Temporary Easement shall not be changed by excavation or filling without VA's prior written consent (both of which consents may be withheld in the sole and absolute discretion of VA). Any construction by the Grantor in connection with the rights so reserved shall be at the expense of the Grantor.
- 3. Grantee acknowledges and reaffirms Grantor's existing rights to water usage by means of a 3/4 inch tap from the Grantee's water line in accordance with (1) the Warranty Deed to the United States of America dated 9/2/1921, and recorded in the Sheridan County Clerk's Office at Book 16, Page 312 and (2) the Warranty Deed to the United States of America dated 9/2/1921, and recorded in the Sheridan County Clerk's Office at Book 531, Page 529.
- 4. Except in the event of an emergency, Grantee shall provide a minimum of fortyeight (48) hours written advance notice to Grantor prior to initiating work under the terms of this Temporary Easement detailing the commencement of the twelve (12)

month period and the estimated period of construction anticipated by Grantee affecting Grantor's property.

- 5. The Grantee shall replace, repair, restore, or relocate any property of the Grantor affected or damaged directly or indirectly by the construction, reconstruction, installation, operation, maintenance, and replacement of said facilities.
- 6. The easement granted herein shall run with land, burden the Temporary Easement area, as more particularly described within Exhibit B, "Legal Description of Property," and in Exhibit B-2, "Survey of Easement Area," attached hereto and incorporated by reference herein.
- 7. The liability, if any, of the United States of America for injury or loss of property, or personal injury or death shall be governed exclusively by the provisions of the Federal Tort Claims Act.
- 8. This instrument shall be binding upon Grantor, Grantee, and their respective successors, successors-in-title and assigns.
- 9. As used herein, the terms Grantor and Grantee shall be deemed to be refer individually and collectively to Grantor, Grantee, and their respective successors and successors-in-title and assigns.
- 10. Easement agreement including the conditions thereof between Double Eagle, LLC and Thorbardin, LLC, recorded on September 10, 2007, in the Sheridan County Clerk's Office at Book 489, Page 81.
- 11. Terms and conditions as shown on a survey, dated April 9, 2011, and recorded in the Sheridan County Clerk's Office at Book A of Plats, Page 438.
- 12. Mortgage and terms and condition thereof to the First Interstate Bank, dated January 24, 2013, and recorded in the Sheridan County Clerk's Office at Book 852, Page 753, subject to the subordination agreement, dated this day of \_\_\_\_\_\_, 2015, and recorded herewith.




