DECREE ESTABLISHING RIGHT AND TITLE TO REAL PROPERTY

The Application for Decree Establishing Right and Title to Real Property came before the Court on this date. It appears that Notice of Application for Decree Establishing Right and Title to Real Property was duly published pursuant to W.S. §2-1-205 and the Order of this Court, and it appears that no objections were filed within thirty (30) days following the first publication of the said Notice. Therefore, after reviewing the Application, the Court finds as follows:

- 1. That Carroll A. Tetschner died on October 3, 2015, in Sheridan County, Wyoming, and was a resident of Sheridan County, Wyoming at the time of his death.
- 2. That at the time of his death, Carroll A. Tetschner owned the following described real property which is situated in Sheridan County, Wyoming.

An undivided one-half (1/2) interest in the following described property, to-wit:

Lots 11, 12, 13, 14, 15, 16 and the South half of Lot 17, all in Block 12, Coffeen's Second Addition to the Town, now City of Sheridan, Sheridan County, Wyoming, together with all appurtenances thereunto appertaining or belonging.

- 5. That more than thirty (30) days have elapsed since the death of Carroll A. Tetschner.
- 6. That no application for appointment of a Personal Representative is pending, or has been granted in any jurisdiction, and no such application is contemplated.
- 7. That Rebecca L. Tetschner is entitled to a Decree Establishing Right and Title to Real Property in her.
- 8. That there are no other distributees of Carroll A. Tetschner having a right to succeed to the above described real property, and no other person has any right, title, or interest in the real property.
- 9. That all right, title, and interest in the above described real property should be distributed to and vest in the person named in the Application.
- IT IS, THEREFORE, HEREBY ORDERED, ADJUDGED AND DECREED that all right, title and interest in and to the following described real property, to-wit:
