Paragraph No. 41 of the Declaration of Protective Covenants of Wild Turkey hereby amended to read as follows:

## **Enforcement of Covenants.**

- costs for the improvement, maintenance and repair of the irrigation system and to allocate and assess costs to ensure that roads are maintained, snow shall have the sole and exclusive right and authority to allocate and assess costs for the improvement, maintenance and repair of the irrigation system other activity that keeps the subdivision in good repair and appearance. removed from the roads, noxious weeds are controlled and to perform any compliance with, interpret and enforce the covenants contained herein, and Landowners Association shall have the right and authority to The Board of Directors of the Wild Turkey Subdivision determine
- Subdivision shall remain the same. In all other respects, the Declaration of Protective Covenants of Wild Turkey
