With regard to the reservation of water, water rights, reservoir water rights and interests, ditch and ditch rights, each lot owner agrees to join in and consent to any petition filed by the Declarants, or any one of them, pertaining to the transfer, change in place of use or kind of use, change in point of diversion, amendment of certificate of appropriation, sale or other disposition of these water rights or any portion thereof to other lands or uses as designated by the Declarants, or any one of them.

These covenants shall be supplemental to and be governed by the procedural and other appropriate provisions of those covenants made the 18th day of May, 1978, by Heights Development Corporation.
