ONE DOLLAR AND OTHER VALUABLE CONSIDERATION DOLLARS,

in hand paid, receipt whereof is hereby acknowledged, Convey and Warrant to

WILLIAM HASSEY

Grantee, of Sheridan

County, and

State of Wyoming the following described real estate, situate in Sheridan

County

and State of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of

the State, to-wit:

The right to lay and maintain at all times a line of pipe in and across the Southeast quarter of the Northeast quarter of Section 32 in Township 57 North, range 86 West on the following described line across said land: Beginning at a point which is South 32 degrees 10 minutes East 405 feet from the Northwest corner of the Southeast quarter Northeast quarter of said section 32, thence South 82 degrees no minutes East 354 feet, thence North 88 degrees no minutes East 290 feet, thence North 78 degrees 55 minutes East 483 feet to a point on the East line of the East half of the Northeast quarter of said Section 32. It is a condition of this grant that said pipe shall at all times be laid at a depth of not less than four feet below the surface of the soil and shall be so maintained as not to cause damage to the owner or owners of the above described land. The grant hereby made shall be perpetual and shall enure to the benefit of the grantee herein, his heirs, executors, administrators and assigns and shall be binding upon the grantors, their heirs, executors, administrators and assigns.

Also All right and interest in the pipe line being in and across the property hereinabove described.

Provided however, that this grant be subject to that certain warranty deed made by the grantors herein in favor of Walter Upton, of Sheridan County, Wyoming, under date of June 29, 1930, said deed having been recorded in the office of the County Clerk, and Ex-Officio Register of Deeds of Sheridan County, Wyoming, in Book 27 of Deeds at page 566.
