Beginning at the SW corner of Section 2, T57N, R83W, Sheridan County, Wyoming, (POINT OF BEGINNING); thence bearing approximately N84°06'E for an approximate distance of 1,833', to the point where Powder River Energy Corporation's new three-phase overhead power line begins on Pilch Ranch property (TRUE POINT OF BEGINNING).

The new three-phase overhead power line continues from this point bearing approximately S08°51'W for an approximate distance of 179'; thence bearing approximately S18°53'W for an approximate distance of 196', where the new powerline terminates on Pilch Ranch property (POINT OF ENDING) this point being located on an approximate bearing of S89°33'E and at an approximate distance of 1,582' from the SW corner of Section 2, T57N, R83W, Sheridan County, Wyoming.
