Beginning at the NW corner of Section 11, T57N, R83W, Sheridan County, Wyoming, (POINT OF BEGINNING); thence bearing approximately S89°33'E for an approximate distance of 1,582', to the point where Powder River Energy Corporation's new three-phase overhead power line enters Fauber property (TRUE POINT OF BEGINNING).
