

The parties further understand that the property will be used exclusively for agricultural purposes until a property request is made and the County grants a subdivision permit allowing this division of property for non-agricultural purposes The Grantees specifically acknowledge that any future conveyance of the subject property will be subject to the Covenant contained herein.

The undersigned state and agree that they have executed this Covenant in good faith and not for the purpose of evading the *Rules and Regulation Governing the Division of Land in Sheridan County, Wyoming*. Further, it is understood that this covenant shall have no bearing on taxation that the property may be subject to pursuant to Wyoming Statutes, Title 39.
