DRAINAGE FACILITY EASEMENT

That for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable considerations, the receipt of which is hereby acknowledged and confessed, DANA R. SCHLICTING and DOROTHY J. SCHLICTING, husband and wife, as tenants by entirety, hereinafter called the grantor, hereby grants to THE TRANSPORTATION COMMISSION OF WYOMING, 5300 Bishop Blvd., Cheyenne, Wyoming, 82009-3340, its assigns or successors, hereinafter called the grantee, the right to lay out, construct, inspect, maintain and operate drainage facilities, and the right to discharge drainage and flood waters for the benefit of the public, being over, across and upon the following described lands located in the County of Sheridan and State of Wyoming, to-wit:

A portion of Lot 1 of the Winding Brooks Meadows 2nd Addition located in Section 14, T.54N., R.83W. of the 6th P.M., Sheridan County, Wyoming, being more particularly described by metes and bounds as follows:

Beginning at a point on the presently existing right or southwesterly right-of-way boundary of U.S. Highway 14 from which the north quarter-corner of said Section 14 bears N.27°15'30.1"E. a distance of 782.791 meters (2,568.21 feet), said corner being monumented with a brass survey cap LS 520 and from which the northwest corner thereof bears N.32°44'07.4W. a distance of 843.600 meters (2,767.71 feet), said corner being monumented with an aluminum survey cap LS 2615;
