Re: Huebner Boundary (After Boundary Line Adjustment with Stolcis)

A tract of land situated in the SW¹/₄SE¹/₄ of Section 22, Township 55 North, Range 84 West, 6th P.M., Sheridan County, Wyoming; said tract of land being more particularly described as follows:

Commencing at the south quarter corner of said Section 22 (Monumented with a 31/4" Aluminum Cap per PE&LS 3864); thence N45°50'24"E, 490.13 feet to the POINT OF BEGINNING of said tract, said point lying on the easterly right-of-way line of U.S. Highway No. 87; thence, along said easterly right-of-way line of U.S. Highway No. 87 through a non-tangent curve to the right, having a central angle of 01°16'36", a radius of 1859.86 feet, an arc length of 41.45 feet, a chord bearing of N25°00'24"E, and a chord length of 41.45 feet to a point; thence, along said easterly right-of-way line of U.S. Highway No. 87, fifty (50) feet easterly of and parallel to the CENTERLINE of said U.S. Highway No. 87, a spiral curve to the right having a centerline radius of 1909.86 feet, a central angle of 72°59', a centerline curve length of 2012.8 feet, a centerline spiral length of 420.00 feet, a RIGHT-OF-WAY spiral chord bearing of N27°40'02"E, and a RIGHT-OF-WAY spiral chord length of 149.96 feet to a point; thence S58°02'38"E, 1.84 feet along said easterly right-of-way line of U.S. Highway No. 87 to a point; thence N31°56'55"E, 267.74 feet along said easterly right-of-way line of U.S. Highway No. 87 to a point; thence, along the westerly right-of-way line of Maverick Drive (AKA County Road No. 1213) through a non-tangent curve to the right, having a central angle of 21°59'28", a radius of 134.52 feet, an arc length of 51.63 feet, a chord bearing of S42°38'12"E, and a chord length of 51.31 feet to a point; thence, along said westerly right-of-way line of Maverick Drive (AKA County Road No. 1213) through a non-tangent curve to the left, having a central angle of 33°59'37", a radius of 508.77 feet, an arc length of 301.85 feet, a chord bearing of S28°15'23"E, and a chord length of 297.45 feet to a point; thence S45°18'24"E, 160.25 feet along said westerly right-of-way line of Maverick Drive (AKA County Road No. 1213) to a point; thence N88°15'05"W, 520.12 feet to the **POINT OF BEGINNING** of said tract.
