KNOW ALL MEN BY THESE PRESENTS: That for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, the undersigned, THERESIA SCHILLING, a widow, Grantor, does hereby grant and convey to DAYTON RANCHESTER POST NO. 10105, VETERANS OF FOREIGN WARS OF THE UNITED STATES, INC., a Wyoming Corporation, and its successors in interest, Granted, an easement and right-of-way for the following described sewer line:

i.

A twenty (20) foot wide sewer easement located in the SE/4SE/4 of Section 18, Township 57 North, Range 85 West of the 6th P.M., Town of Ranchester, Sheridan County, Wyoming, and has a centerline described as follows:

Beginning at a point on the West line of a tract, said point being located North, 106.02 feet from a point on the Northerly right-of-way of the Burlington Northern railroad, which point is 738.5 feet East from a point 130 feet North of the Northwest Corner of Block 1, Town of Ranchester, Wyoming; thence N75°57'12.5" E., 123.06 feet; thence N.69°21'52.8" E., 254.74 feet to the point of ending. Said easement contains 0.17 acres, more or less.

A Plat reflecting the location of said sewer line is attached hereto, marked Exhibit "A" and by reference thereto, made a part hereof.

to enable the Grantee to serve the property which is described in a Warranty Deed from the above-named Grantor in favor of the above-named Grantee, which was recorded on July 23, 1985 in Book 294 of Deeds at Page 633 in the Office of the CountyClerk of Sheridan County, Wyoming.

This right-of-way and easement is hereby granted by the Grantor to the Grantee, subject to the following conditions:

- (1) The Grantee, or its successor in interest, or employee, may come upon said premises for the purpose of servicing or relaying said sewer line
- (2) The Grantee shall be responsible for any damage that may occur to the lands of Grantor as a result of servicing said

easement, and shall restore said land to its original condition, in the event it is necessary to repair or replace said sewer line.
