Beginning at the SW corner of Section 33, T55N, R76W, Sheridan County, Wyoming, (POINT OF BEGINNING); thence bearing approximately N82°12'W for an approximate distance of 125', to the point where Powder River Energy Corporation's new three-phase overhead power line begins on Malli property (TRUE POINT OF BEGINNING).

The new three-phase overhead power line continues from this point bearing approximately N01°23'W for an approximate distance of 641', where the power line crosses off of Malli property (POINT OF ENDING), this point being located on an approximate bearing of N11°43'W and at an approximate distance of 655' from the SW corner of Section 33, T55N, R76W, Sheridan County, Wyoming.
