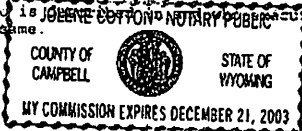

ADDENDUM

Addendum to the Right-of-Way Easement from Don C. and Betty Ann Malli for a buried telecommunications cable, according to Wyoming State Law.

Commencing at the Northwest corner marker of Section 1, T 54N, R 77W of the Principal Meridian Wyoming, thence South 1°0' West for a distance of 750 feet to the point of beginning of the buried telecommunications cable.

Thence North 78°0' East for a distance of 2500 feet. Thence North 82°0' East for a distance of 200 feet. Thence North 88°0' East for a distance of 1900 feet to a POT of Range Telephone pedestal C6B.
