STOCK WATER WELL LICENSE AND SHARING AGREEMENT

Donald Ray Spellman and Kathleen Spellman, husband and wife, of 7239 Hwy. 14-16 Unit C, Arvada, Wyoming 82831 ("Spellmans") and Vineyard Cattle Company, LLC, a Wyoming limited liability company, of Box 52, Arvada, Wyoming 82831 ("Vineyard"), hereby enter into the following water well license and sharing agreement.

RECITALS

WHEREAS, Spellmans have recently purchased lands from Vineyard that include lands located in Sheridan County, Wyoming in T 54 North, R 77 West, 6th P.M., Section 1 and there is a stock water well located in that area nearly adjacent to the lands purchased by Spellmans upon which is locate a stock water well that exists by virtue of a State of Wyoming Board of Control ground water appropriation Permit No. UW 194454 for the Malli 4-1-54-77A well as shown in the attached Exhibit "1" diagram (the "Well"); and,

WHEREAS, the parties desire to enter into an agreement that will allow them to share access and use of said Well as set out in this Agreement.

AGREEMENT

THE PARTIES THEREFORE HEREBY AGREE AS FOLLOWS:

- 1. Spellmans License to Use Stock Water Well. Spellmans may, at their sole expense, use water produced from the well and delivered through an existing water pipeline to a tire stock tank that straddles the parties' mutual fence line roughly three-quarters of a mile North of the Well. Spellmans shall have reasonable access to check on the Well on or across Vineyard's lands with notice to Vineyard and the parties shall cooperate in good faith concerning the use of the well and the shared tire stock tank.
- Term. The term of this Agreement shall be for the useful life of the stock water well designated in the State of Wyoming Board of Control order Record as the Well. The license described in this Agreement shall promptly terminate if the Well is abandoned or is not used and maintained for one (1) calendar year or more or is plugged. The license described in this Agreement shall also be specific to Spellmans according to the terms of this Agreement and may not be assigned or otherwise transferred to any other person or entity except as expressly allowed by the terms of this Agreement.
- Assignment. This Agreement shall be otherwise binding upon Vineyard and its respective heirs, successors and assigns.
- 4. **Time.** Time is of the essence in this Agreement.
- Governing Law. This Agreement shall be governed by and construed according to the laws of the State of Wyoming.


