CONVEYANCE AND ASSIGNMENT

KNOW ALL MEN BY THESE PRESENTS; THAT,

SHELL OIL COMPANY, a Delaware corporation, hereinafter referred to as "Shell Oil", for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby grant, assign, transfer, convey, set over and deliver to SHELL WESTERN E&P INC., a Delaware corporation, hereinafter referred to as "SWEPI" and whose mailing address is P. O. Box 576, Houston, Texas 77001, all and the entire of Shell Oil's right, title, interest and obligations in, to, under and arising out of or in any way related to each and every property described in the instruments listed on Exhibit "A" attached hereto and made a part hereof, as said instruments may have been modified or amended whether or not such modifications or amendments are listed on Exhibit "A" hereto, which right, title, interest and obligations shall include, but are not specifically limited to the following:

1. Leasehold interests in oil, gas or other minerals, including working interests, carried working interests, rights of assignment and reassignment, and other interests under or in oil, gas or mineral leases, and interests in rights to explore for and produce oil, gas and other minerals;
2. Royalties, overriding royalties, production payments, rights to take royalties in kind, or other interests in production of oil, gas or other minerals;

3. Fee or term interests or estates in lands or in oil, gas or other minerals in, on or under lands, or in the surface of lands, including such interests held or used for operations for processing and/or fractionation of natural gas and/or extraction and recovery of sulfur, but excluding any such interests held or used exclusively for operations for refining, manufacturing, distribution or marketing of petroleum products or chemical products;
4. Rights and interests in or derived from unit agreements, orders and decisions of state and federal regulatory authorities establishing units, joint operating agreements, enhanced recovery and injection agreements, boundary or line well agreements, farmout agreements and farmin agreements, options, drilling agreements, exploration agreements, joint bidding agreements, assignments of operating rights, working interests, subleases and rights above or below certain footage depths or geological formations;
5. Rights-of-way, easements, servitudes and franchises acquired or used in connection with operations for the exploration and production of oil, gas or other minerals; and
6. Permits and licenses of any nature owned, held or operated in connection with operations for the exploration and production of oil, gas or other minerals.

As used herein, the term "oil, gas or other minerals" shall mean oil, all gaseous substances, sulfur and/or other minerals.

All interests conveyed and assigned hereunder which are subject to valid and subsisting joint operating agreements, unit agreements, farmout agreements or farmin agreements or other agreements are hereby expressly declared to be and remain subject thereto; and it is made a condition of this Conveyance and Assignment that SWEPI hereby agrees in writing

to assume all of the obligations and liabilities of Shell Oil under said joint operating agreements, unit agreements, farmout agreements or farmin agreements or other agreements, as such written assumption may be required under the terms thereof.

If the consent of, or notice to, third parties is required in connection with any of the properties or interests conveyed and assigned herein, Shell Oil undertakes to obtain any and all such consents and to give any and all such notices, which if not accomplished by the effective date hereof will be accomplished within a reasonable time. Should any prior consents from third parties be required which if not obtained before the effective date hereof would cause such affected interests to be forfeited or terminated, then such interests so affected are excluded herefrom and shall be transferred to SWEPI as of the effective date hereof if, as and when such consents are obtained, and Shell Oil shall execute such further instruments as may be necessary to accomplish such transfer. This Conveyance and Assignment is made specifically subject to any necessary local, state and/or Federal government approvals.

It is the intention of Shell Oil and SWEPI that this Conveyance and Assignment should cover interests in adjacent counties which are unitized or operated together with interests in Sheridan County, Wyoming, which interests are of the kinds enumerated above.

Shell Oil does hereby grant, assign, transfer, convey, set over and deliver to SWEPI all and the entire of Shell Oil's right, title and interest in and to any and all production of oil, gas or other minerals which right, title and interest arises out of or is in any way related to any joint operating agreement, unit agreement, farmout agreement or farmin agreement, or other agreement, whether or not the property rights, title, interest and obligations underlying said agreement remain in effect or have been terminated.

Shell Oil hereby delivers to SWEPI and SWEPI hereby accepts this Conveyance and Assignment and the right, title, interest and obligations transferred hereby, and the parties agree when and if necessary, to record this Conveyance and Assignment and any other instruments or any recordable memoranda hereof or thereof, necessary to implement the transfers herein.

SWEPI hereby assumes all the obligations and liabilities of Shell Oil as of the effective date hereof with respect to rights, interests and obligations herein transferred and agrees to perform all such obligations and discharge all duties and liabilities with respect thereto.

All and singular the terms, conditions, declarations and assumptions hereof shall bind and inure to the benefit of the respective successors and assigns of the parties hereto.

This Conveyance and Assignment including all obligations and liabilities assumed herein shall be binding upon the

parties hereto, their successors and assigns, and any obligations so assumed may be performed by successors and assigns on behalf of the parties hereto.

The effective date of this Conveyance and Assignment shall be January 1, 1984.

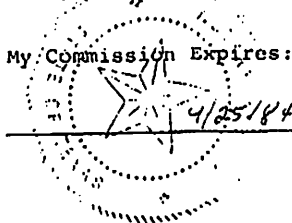

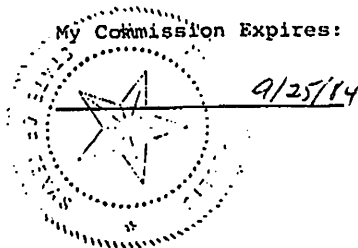

EXHIBIT A

To Conveyance and Assignment
from Shell Oil Company to
Shell Western E&P Inc.
Effective January 1, 1984

This Exhibit identifies documents under which Grantor owns and holds for oil and gas exploration and production purposes an interest in the land described. The omission from this Exhibit of a reference to a pertinent title document shall not affect the intent and purpose of the Conveyance and Assignment to convey title to the Grantee of all of Grantor's right, title and interest in lands presently held by Grantor for oil and gas exploration and production purposes.

Lands are described in the Exhibit as being situated in a "Parish" (Louisiana), or in a "Recording District" (Alaska), or in a "County" (all other states).

The recording data set out for a document refers to the Volume and Page of the appropriate set of records in which such a document is recorded in the County or Parish or Recording District, or refers to the Entry or File number assigned to such document in the records of such County or Parish or Recording District.

The kind of document is identified in this Exhibit by the letter prefixes to Shell's File No. in accordance with the following:

OP: an option to acquire an interest in land
