

- 3. I certify that Melba Batt, spouse of George Batt, died on May 19, 1989, in Sheridan County, Wyoming. Attached hereto is a copy of the official Death Certificate of Melba Batt, certified to by the public authority in which the original Death Certificate is a matter of record.
- 4. I certify that George W. Batt, died on January 29, 2021, in Sheridan County, Wyoming. Attached hereto is a copy of the official Death Certificate of George W. Batt, certified to by the public authority in which the original Death Certificate is a matter of record.
- 5. On May 10, 1974, Michael G. Jurosek and Donna Jurosek, husband and wife, as Grantors, executed and delivered a Warranty Deed to George W. Batt and Melba Batt, husband and wife, as tenants by the entirety with full right of survivorship, as Grantees. The Warranty Deed was recorded on June 16, 1977, in Book 222, Page 473, as Document No. 711640, in the Office of the Sheridan County Clerk, Sheridan County, Wyoming, and conveyed to the Grantees the following described real estate, situate in Sheridan County, State of Wyoming:
