- 2. That notice of the Application for Decree of Distribution was published once a week for two consecutive weeks in the *The Sheridan Press*, a newspaper of general circulation in Sheridan County, Wyoming.

3. Kristine Brisendine filed an objection on August 10, 2021. The Court held a hearing on September 28, 2021 on the objection, which was resolved at the hearing by stipulation of the parties to the form of this Decree. That no other objections to the Application for Decree of Distribution have been filed with the Court that would prevent title to the property from passing to the Applicant and that it appears that the facts stated in the Application are not in dispute.
