The undersigned agrees that all poles, wires and other facilities, including all telephone equipment, installed on the above-described premises at the Company's expense, shall remain the property of the Company, removable at the option of the Company.

#### ADDENDUM

Addendum to the Right-of-Way Easement from Stanley V. and Shari L. Peddicord for a buried telecommunications cable, according to Wyoming State Law.

Commencing at the Southwest corner marker of Section 20, T58N, R82W of the Principal Meridian Wyoming, thence North  $1^{\circ}0'$  East for a distance of 2800 feet to the point of beginning of the buried telecommunications cable. Thence North  $70^{\circ}0'$  East for a distance of 1500 feet. Thence North  $20^{\circ}0'$  East for a distance of 200 feet. Cable lays approx. 20 feet outside road right-of-way and runs parallel to the north side of the Badger Creek road through section 20.
