ORDER APPROVING FINAL REPORT, ACCOUNTING AND DECREE OF DISTRIBUTION

THIS MATTER having come before the Court upon the *Final Report, Accounting and Petition for Distribution* filed herein by **Geri P. Rogers and Carmen Christian**, the duly appointed and qualified Co-Personal Representatives of the Estate of Richard James Rogers, Jr., and the Court now being duly and fully advised in the premises, finds that Geri P. Rogers, the sole heir at law of decedent was mailed the *Final Report, Accounting and Petition for Final Distribution* and has waived the accounting and notice of hearing.
