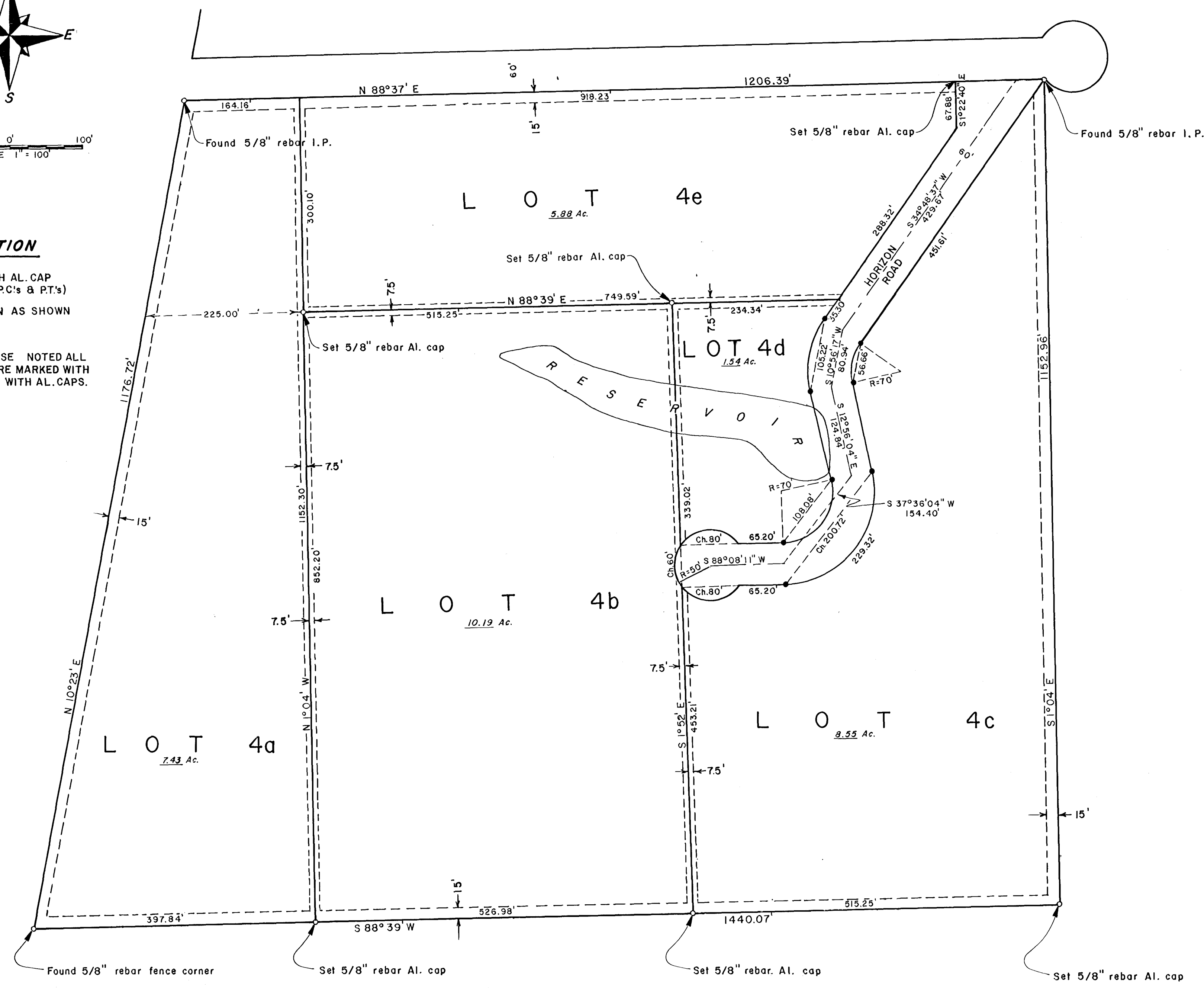


MONUMENTATION

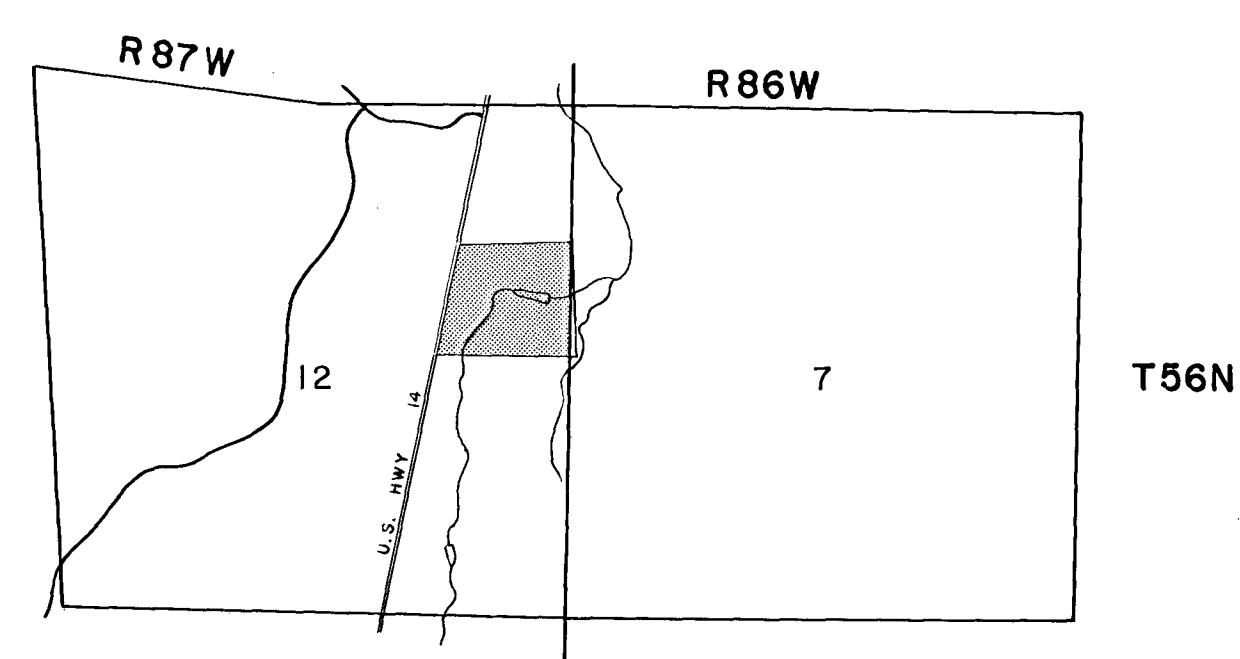


NO PUBLIC MAINTENANCE OF STREETS OR ROADS
