## MUSKRAT DITCH AGREEMENT

THIS AGREEMENT, made and entered into this 15 day of July, 1933, by and between EDWARD S. MOORE, of Nassau County, State of New York, and E. BRYAN KELSO, of Sheridan County, State of Wyoming,

WITNESSETH: That

WHEREAS, the parties hereto are the sole owners of Muskrat ditch; and

WHEREAS, it is desired to establish of record the respective interests of the parties hereto in the Muskrat ditch,

NOW, THEREFORE, it is agreed that Edward S. Moore, the Party of the First Part, is the owner of an undivided four-fifths ( $\frac{4}{5}$ ths) interest in said ditch and is entitled to carry water through said ditch upon, over and across the -

Southwest Quarter of the Northwest Quarter ( $\frac{1}{4}$ SW $\frac{1}{4}$ ) and the West Half of the Southwest Quarter ( $\frac{1}{2}$ SW $\frac{1}{4}$ ) of Section Nine (9); and the Northeast Quarter of the Northeast Quarter ( $\frac{1}{4}$ NE $\frac{1}{4}$ ) of Section Seventeen (17);

and the party of the Second Part is entitled to have water from said ditch upon twenty (20) acres of land in the -

Southeast Quarter of the Southeast Quarter ( $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section Eight (8), all in Township Fifty-four (54), North of Range Eighty-four (84), West of the Sixth Principal Meridian;

and that the interest of the Party of the First Part in said ditch is an undivided four-fifths ( $\frac{4}{5}$ ths) interest, and the interest of the Party of the Second Part in said ditch is an undivided one-fifth ( $\frac{1}{5}$ th) interest.

The parties hereto and their respective heirs, representatives and assigns, shall share in the above proportions in all rights and obligations in said Muskrat ditch.
