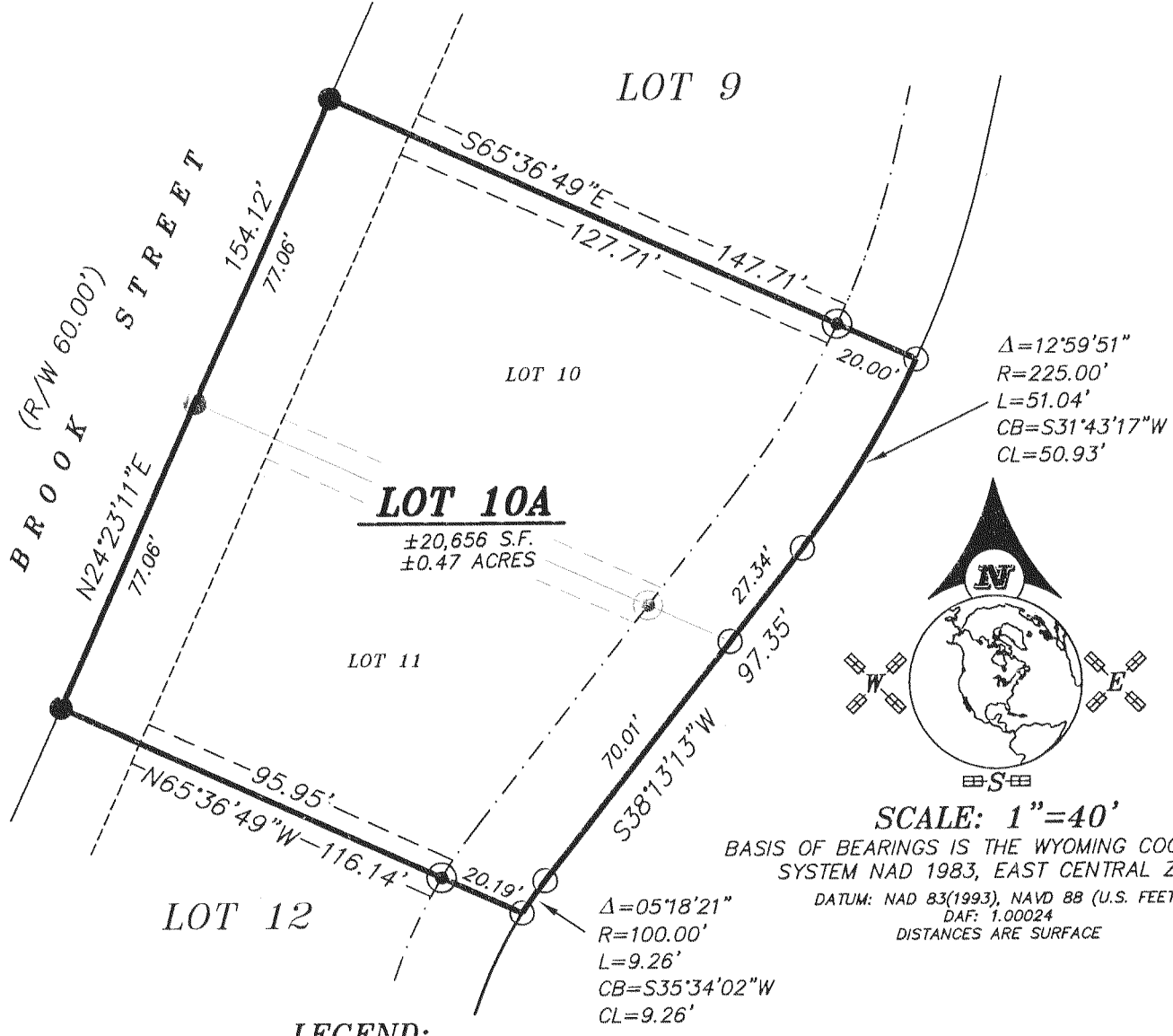


STONEBROOK MEADOWS SUBDIVISION

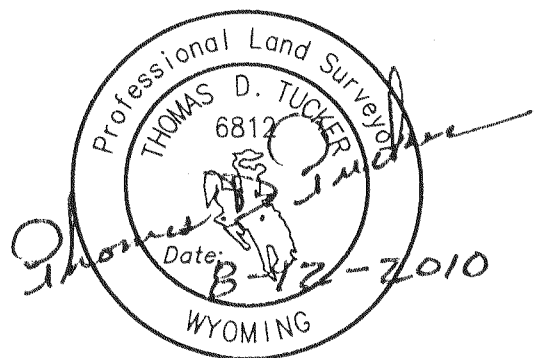
NOTES:
