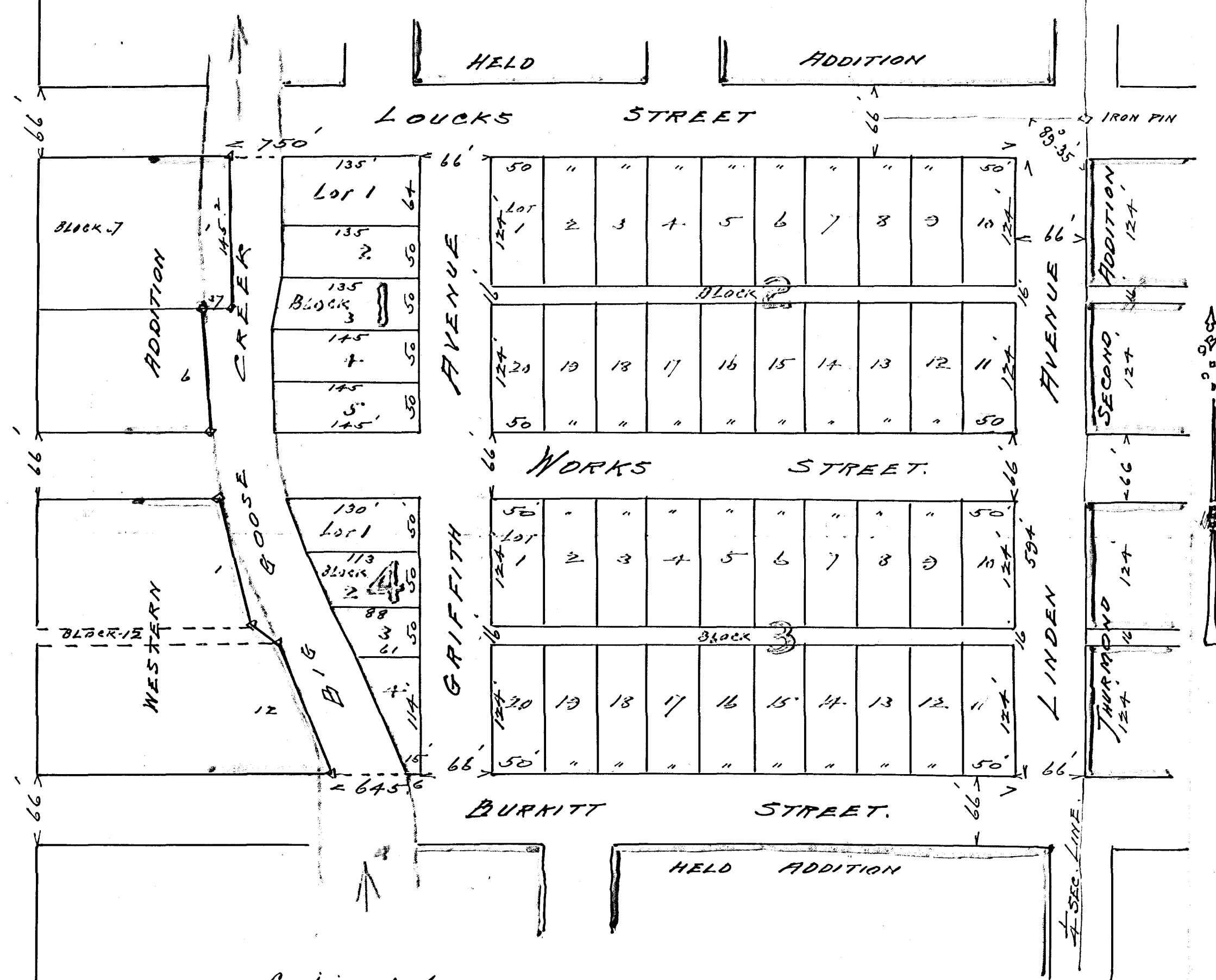


Griffith Addition

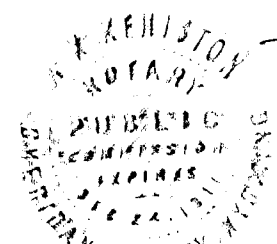
TO THE CITY OF SHERIDAN

Griffith Addition to the City of Sheridan, Sheridan County, Wyoming.
This is to certify that Ida B. Stevenson and Vernon S. Griffith
are the owners and proprietors of an unplatted tract of land lying in the
N.E. 1/4 of the S.W. 1/4 of Section 17, Township 26 North, Range 84 West of the
6th P.M. in Wyoming and more particularly described as follows, to wit:
Beginning at the North East corner of Lot 1, Block 7, Western Addition to the City of Sheridan
Sheridan County, Wyoming; thence South 145.70 feet to the North East corner
of said Lot 1, Block 7; thence West 37 feet to the North East corner of Lot 6
Block 7, said Western Addition; thence South 10 East 120 feet to the
South East corner of said Lot 6; thence South 6 East 66 feet to the North
East corner of Lot 1, Block 12, said Western Addition; thence South 15 East 129 feet
to the North East corner of said Lot 1, Block 12; thence South 60 East 36 feet
to the North East corner of Lot 12, Block 12, said Western Addition; thence South
22 East 134 feet to the South East corner of said Lot 12, Block 12, being a
description of the East boundary line of said Western Addition, from the
South end of Loucks Street to the North side of Burnett Street; thence
East 645.70 feet, more or less, along the North side of Burnett Street to a
point 66 feet West of the North West corner of Lot 12, Block 2, Thummond
2nd Addition to the City of Sheridan, Sheridan County, Wyoming; thence
North 597 feet, along the West side of Linden Avenue to a point 66 feet
West of the North West corner of Lot 1, Block 1, said Thummond 2nd Addition;
thence West along the South side of Burnett Street, 750 feet, more or less, to
point of beginning, containing 10 acres, more or less.
That the said owners and proprietors have caused said land
to be surveyed and platted as Griffith Addition, to the City of Sheridan
Sheridan County, Wyoming; that the streets and alleys indicated on said
plat are dedicated to the public use and the accompanying plat to be made
with the free consent and in accordance with the desire of said owners and proprietors,
We also certify that the land is no wise homestead in character.
