CERTIFICATE OF PARTIAL VACATION OF PLAT

WHEREAS, Excalibur Construction, a Wyoming company, (herein the "Owner"), is the sole record owner of the following described real property, to wit:

Lot B of Hidden Bridge Minor Subdivision, a Resubdivision of Tract 1 and Tract 2 of Sheridan Country Club Minor Subdivision, City of Sheridan, Sheridan County, Wyoming, recorded April 30, 2013 in Drawer H, Plat No. 58 (the "Property");

WHEREAS, Owner desires to partially vacate said Property as shown on the Plat, and desires that the said Plat be partially vacated, as to the Property only, in accord with the fully-executed plat filed contemporaneously herewith at the office of the Sheridan County Clerk for the sole purpose of re-platting said Property.

WHEREAS, there are no other lots, tracts or parcels that have access to a public highway through the Property, whether by easement for right of way or otherwise which would be adversely affected by the re-plat of said Property;

THEREFORE, the undersigned, being the sole record owner and proprietor of the foregoing described lands, in compliance with Wyoming Statute Sections 34-12-106 through 111, does hereby vacate and declare vacated the foregoing described lands as to the legal description thereof. The undersigned further declares that the plat above described, is hereby partially vacated and of no further force and effect. The undersigned acknowledges that easements for existing utilities and State and County roads that may be within the boundaries of the vacated lands are reserved for continued use.

THEREFORE, Owner hereby vacates that Lot B described above and the dedication of the Property is hereby revoked and terminated in accordance with the approval and consent of the Sheridan City Council. Owner, by these presents, does make the above partial vacation for it and for its successors and assigns, and for all future owners of said Property, as the same shall be re-platted as HIDDEN BRIDGE RANCH SUBDIVISION.

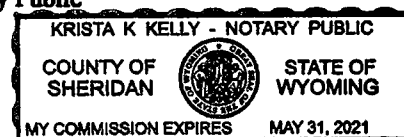

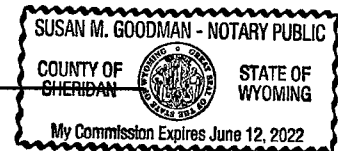
